#### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: an amendment to the previously approved annual and daily permit fee policy for saltwater boat ramp trailer parking to include a commercial permit for boat dealerships and boat repair facilities with an annual fee of \$150.00.

**Summary:** On July 7, 2009, the Board approved an annual boat trailer parking fee of \$35.00 for five (5) County saltwater boat ramp locations (Bert Winters, Burt Reynolds, Juno, Jim Barry Light Harbor, and Phil Foster Parks), and on October 6, 2009, the Board approved a daily fee for boat trailer parking of \$10.00. A commercial annual permit for boat dealers and boat repair facilities with an annual fee of \$150.00 is proposed to accommodate those businesses which utilize the boat trailer parking spaces frequently, but for short duration for test drives, checking repairs, etc. The same permitting process used for annual and daily permits can accommodate the commercial permit at no additional cost to the County. Background and Justification: In 2009 the Board approved annual and daily fees for boat trailer parking at the County's five (5) saltwater boat ramps. Subsequent to implementation of the fees on January 1, 2010, the boat dealers and repair facility operators suggested that some type of commercial permit be made available due to their frequent use of the boat ramps for showing boats to potential customers and for testing of repairs. Their use could be several times per day utilizing different trailers each time which, under current policy, would require an annual or daily fee for each trailer. The dealers have many trailers and there is constant turnover in their inventories. Requiring the current annual or daily permit would be cumbersome and expensive for boat dealers and repair facilities. The commercial permit would be portable, allowing dealers and repair facility operators to display the commercial boat trailer parking permit on the dashboard of their tow vehicles.
