## **I. EXECUTIVE BRIEF**

**Motion and Title: Staff recommends motion to approve:** A Contract with H & J Contracting, Inc. (Contractor), the lowest, responsive, responsible bidder, in the amount of \$117,228.03 for "A" Street Paving & Drainage Improvements (Project), No. 2006132.

**SUMMARY:** Approval of this Project will allow construction of paving and drainage improvements for approximately 600 lineal feet (0.11 miles) of road on "A" Street. This work includes new pavement, driveway reconstruction, and a drainage stormwater management system. The Contractor is a Palm Beach County business. The Small Business Enterprise (SBE) goal for the Project is 15%. The SBE participation committed for the Project by the Contractor is 16.77% overall.

**Background and Justification:** The bids were received by the Board of County Commissioners on March 9, 2010. The Project will provide a paved roadway and associated storm sewer resulting in a healthier and safer neighborhood for the residents. This Project is entirely funded by a Community Development Block Grant through Housing and Community Development.

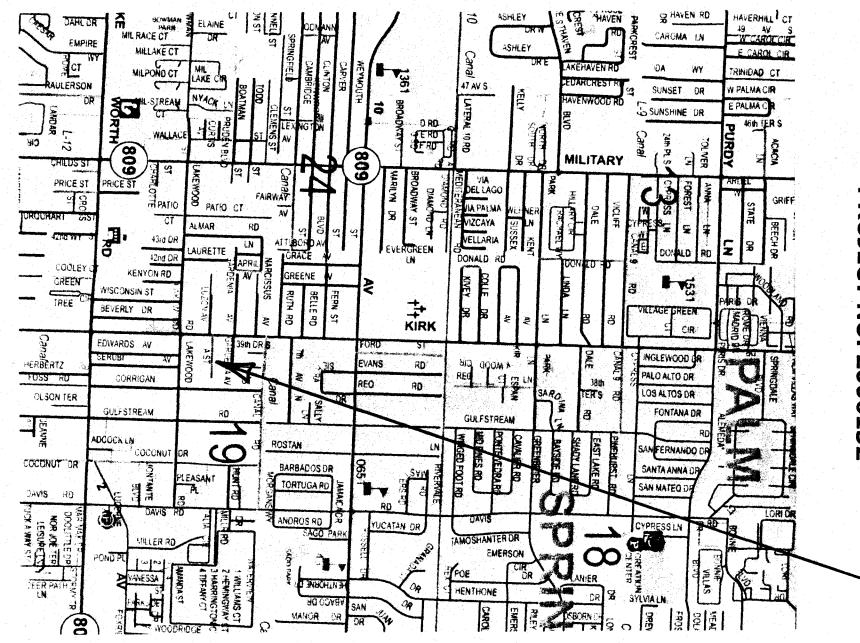
