I. EXECUTIVE BRIEF									

Motion and Title: Staff recommends motion to:

- A) approve Interlocal Agreement with the City of Lake Worth (City) in an amount not to exceed \$210,000 for the installation of a Pollution Control Device through the Lake Worth Lagoon Partnership Grant Program (LWLPGP);
- B) approve Budget Transfer to recognize the re-allocation of \$210,000 from Westgate CRA award to the City of Lake Worth; and
- C) authorize the County Administrator or his designee to sign all future time extensions, task assignments, certifications, statements and other forms associated with this document, and any necessary minor amendments that do not change the scope of work or terms and conditions of this document.

Summary: On September 5, 2008, the LWLPGP Selection Committee approved the reallocation of \$210,000 unspent funds from the State's Department of Environmental Protection (FDEP) Grant Agreement No. LP6046 (R2006-05830) to the City's water quality improvement project. Construction projects benefiting Lake Worth Lagoon habitat and water quality will be administered as subgrants via Interlocal Agreements with the responsible entities. The total grant funding for the projects is \$210,000. A 100% match is required from the local entities. Countywide (SF)

Background and Justification: Since 1998, the State Legislature has supported the restoration and enhancement of Lake Worth Lagoon by appropriating a total of \$15.8 million for the LWLPGP. The County acts as the grant administrator and facilitates a "Request for Proposals" process to solicit projects from local sponsors.

A qualified project is deemed to be a construction project designed to provide measurable improvement to the Lake Worth Lagoon. To date, a total of 44 construction projects to benefit the Lagoon have been selected to receive funding.

On September 5, 2008, the LWLPGP Selection Committee approved the reallocation of \$210,000 unspent funds from the FDEP Grant Agreement No. LP6046 (R2006-05830) to the City's water quality improvement project. The FDEP Agreement will reimburse \$210,000 for the City (2nd Avenue North Outfall Water Quality Improvements). The FDEP Agreement is part of the State Legislature's disbursement of funds for restoring and protecting surface waters of the State. The funds are being allocated and managed under the LWLPGP. The County acts as the pass through agency for the City.
