**Motion and Title:** Staff recommends motion to approve: Amendment 001 to the Contract For Consulting/Professional Services with Multilingual Psychotherapy Centers, Inc. (R2009-1637), for the period of February 1, 2010, through September 30, 2010, to increase the contract amount by \$6,500, for a new not-to-exceed total of \$22,500, to expand mental health services to Early Head Start children.

**Summary:** Additional funding is being provided as a result of the American Recovery and Reinvestment Act (ARRA) Expansion Grant. Multilingual Psychotherapy Centers, Inc. will provide ongoing mental health services to Early Head Start Expansion children and families. Funding consists of \$5,200 (80%) in Federal funds and \$1,300 (20%) in County funds. The County's portion is included in the FY2010 budget. (Head Start) <u>Countywide</u> (TKF).

**Background and Justification:** The Early Head Start Grant Agreement (expansion) requires that services for mental health are provided by licensed professionals. This contract is for mental health services to be provided by mental health professionals in accordance with Head Start/Early Head Start guidelines. The provider was selected based upon their ability to provide the necessary services and willingness to accept Medicaid. Professional medical services are exempt from the purchasing ordinance. Fees are based on flat rates or hourly rates for services rendered. As required in the Early Head Start Grant Agreement (expansion), the mental health provider will: general classroom observations, individual observations/assessments as requested, Home Visits, group team meetings, staff and parent trainings, conduct follow-up, regular on-site visits, provide interventions as needed and provide individual counseling for children with atypical behaviors.

## AMENDMENT 001 TO CONTRACT FOR CONSULTING/PROFESSIONAL SERVICES

THIS AMENDMENT 001 TO THE CONTRACT FOR CONSULTING/PROFESSIONAL SERVICES dated October 6, 2009 (Document No. R2009-1637), made and entered into on this day of \_\_\_\_\_\_, by and between Palm Beach County, a Political Subdivision of the State of Florida hereinafter referred to as COUNTY, and Multilingual Psychotherapy Centers, Inc., a corporation authorized to do business in the State of Florida hereinafter referred to as the CONSULTANT.

## WITNESSETH:

WHEREAS, the need exists to amend the CONTRACT to increase the CONTRACT by \$6,500 for the period of February 1, 2010 through September 30, 2010, in order to extend services to Early Head Start children and families.

**NOW, THEREFORE,** the above named parties hereby mutually agree that the CONTRACT is hereby amended as follows:

- I. So much as Article 3 reads the total amount of services shall not exceed sixteen thousand dollars (\$16,000), is amended to read the total amount of services shall not exceed twenty-two thousand, five hundred dollars (\$22,500), in accordance with the budget set forth herein as Exhibit "B2" hereof.
- II. The existing Exhibit "B1" Schedule of Payments is deleted in its entirety and Exhibit "B2" attached hereto is substituted in its stead.

## **OTHER PROVISIONS**

All provisions in the CONTRACT or exhibits to the CONTRACT in conflict with this AMENDMENT and Exhibits or Attachments thereto are hereby changed to conform to this AMENDMENT.

All provisions not in conflict with this Amendment are still in effect and are to be performed at the same level as originally specified in the Contract.
