| Motion and Title: Staff recommends motion to approve: Amendment 001 to the Contract for Consulting/Professional Services with Marriage & Family Services, Inc. (R2009-1640), for the period of December 1, 2009, through September 30, 2010, to increase the contract amount by \$4,000, for a total not-to-exceed total of \$24,000, to expand mental health services to Head Start children. | | | | | | | |
| Summary: Additional expansion grant funding is being allocated to Marriage & Family Services, Inc. to ensure that ongoing mental health services be provided to Head Start children and families. Funding consists of \$3,200 (80%) in Federal funds and \$800 (20%) in County funds. The County's portion is included in the FY2010 budget. (Head Start) Countywide (TKF). | | | | | | | |
| Background and Justification: The Head Start Grant Agreement (expansion) requires that services for mental health are provided by licensed professionals. This contract is for mental health services to be provided by mental health professionals in accordance with Head Start guidelines. The provider was selected based upon their ability to provide the necessary services. Professional medical services are exempt from the purchasing ordinance. Fees are based on flat rates or hourly rates for services rendered. As required in the Head Start Grant Agreement (expansion), the mental health provider will: general classroom observations, individual and group team meetings, staff and parent trainings, conduct follow-up, regular on-site visits, provide interventions as needed and provide group play therapy for children with atypical behaviors, as deemed necessary. | | | | | | | |

EXHIBIT "B2" SCHEDULE OF PAYMENTS

The Scope of Work to be completed by CONSULTANT as defined in Exhibit "A" consists of specific completion phases which shall be clearly identified on a phase by phase basis upon submission to the COUNTY of certain "deliverables" * aas expressly indicated below. Compensation for the work tasks stated herein shall be in accordance with the following Schedule of Payments:

A. The MENTAL HEALTH PROVIDER will bill HEAD START for services provided to children as follows:

| 1. | General Classroom Observation | \$60/hour |

| 2. | Group Team Meeting | \$60/hour |
| 3. | Individual Team Meeting | \$60/hour |
| 4. | Play Therapy | \$60/hour |
| 5. | Conduct follow-up and generate recommendations to the Mental Health Coordinator for referrals | \$60/hour |
| 6. | Monthly on-site visits | \$60/hour |
| 7. | Mileage to the Glades only from Marriage & Family Services office address | .55 cents |

Authorizations for all services shall be obtained in writing from the Director of Community Services or the Director of Head Star/Early Head Start & Children Services or their designee.

Between October 1, 2009 and September 30, 2010, the total amount of services provided shall not exceed \$24,000.

Nothing below this line
