#### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** A Contract with H & J Contracting, Inc. (Contractor), the lowest, responsive, responsible bidder, in the amount of \$344,048.01, for the Lyons Road Pathway Improvements (Project), Project Nos. 2005081 and 2005081-27.

**SUMMARY:** Approval of this Project will result in construction of pathway improvements along the west and east sides of Lyons Road from north of Lantana Road to Brandy Road. The Project will include drainage, concrete sidewalk, installing chain link fence and new sod. The Project is funded through the Florida Department of Transportation (FDOT) Local Agency Program, and the attached contract has been approved by FDOT. The Contractor is a Palm Beach County business. The Small Business Enterprise (SBE) goal for the Project is 15%. The SBE participation committed by the Contractor is 26% overall.

#### Districts 2 and 6 (MRE)

**Background and Justification:** The bids were received by the Board of County Commissioners on December 15, 2009. Concern was raised regarding the use of reinforced concrete pipe (RCP) when the bids were submitted to FDOT for approval. They were concerned with RCP as a sole-proprietary item rather than bidding the item as "PIPE" and allowing the Contractor to use an FDOT approved pipe material. This has now been set aside by FDOT on a one-time basis only, allowing the Project to go forward after a long delay. The Contractor has confirmed his willingness to hold his bid prices. The Project will provide pedestrian access to the local school. This Project is fully funded through State grants. The Inspector General Fee is exempt.


