above the County's appraised value. Because this proposed settlement is less than 10% above the County's appraised value, it is exempt from the County's Amended Real Property Acquisition, Disposition and Leasing Ordinance, No. 2009-52, as amended, and does not need to go before the Property Review Committee.

The Owner's Appraiser opined that the value of the subject property, parcel 4, was \$650,000. This settlement is fair and equitable, and eliminates the risk and exposure of an adverse jury verdict, additional interest, attorney's fees, expert fees and costs that would exceed the additional cost of settlement.

STIPULATED FINAL JUDGMENT CLOSING CASE AS TO PARCEL 4 OWNED BY ROLANDO RUBEN RAMOS AND ANA MARIA VALDIVIA

THIS CAUSE having come before the Court on the mediated settlement, by Petitioner, Palm Beach County, by and through its undersigned Assistant County Attorney, and Bradley S. Gould, Esquire, Attorney for the Respondents, Rolando Ruben Ramos and Ana Maria Valdivia, and the Court being fully advised in the premises, hereby finds and decides as follows:

- 1. The Court has jurisdiction over the subject matter of, and the parties to this cause.
- 2. Respondents, Rolando Ruben Ramos and Ana Maria Valdivia, shall have and recover the sum of **FIVE HUNDRED FIFTY THOUSAND DOLLARS AND 00/100 CENTS** (\$550,000.00), as full, just and final compensation for the taking of Parcel 4, which includes all damages of any type whatsoever, excluding attorney's fees, expert fees and costs. There are no taxes due on Parcel 4.
- 3. The sum of FIVE HUNDRED ONE THOUSAND DOLLARS AND 00/100 (\$501,000) having been previously deposited by Petitioner into the Registry of the Court pursuant to the Order of Taking entered on January 12, 2007, and having been previously withdrawn by the Respondent, Petitioner shall receive a credit in the sum of \$501,000.00 toward the full and final compensation set forth in paragraph 2 above.

- 4. Petitioner, Palm Beach County, shall within thirty days (30) days from the date of the entry of this Stipulated Final Judgment, issue a check in the amount of FORTY-NINE THOUSAND DOLLARS AND 00/100 (\$49,000.00), made payable to Holland & Knight, LLP, Trust Account, and mail same c/o Bradley S. Gould, Esquire, 701 Brickell Avenue, Suite 3000, Miami, Florida, 33131, representing the difference between the agreed upon compensation referenced in paragraph two and the amount previously deposited into the Registry of the Court for Parcel 4. Respondent's counsel, Bradley S. Gould, Esq., shall be solely responsible to make the appropriate disbursements.
- 5. Additionally, Petitioner, Palm Beach County shall within thirty days (30) days from the date of the entry of this Stipulated Final Judgment, issue a check in the amount of **SIXTEEN THOUSAND ONE HUNDRED SEVENTY DOLLARS AND 00/100 (\$16,170.00)**, made payable to **Holland & Knight, LLP, Trust Account,** and mail same c/o Bradley S. Gould, Esquire, 701 Brickell Avenue, Suite 3000, Miami, Florida, 33131, which sum represents full attorneys fees, expert fees and costs paid on behalf of the Respondents.
- 6. Title to Parcel 4, as further described in **Exhibit "A"** attached hereto, which vested in the Petitioner pursuant to the Order of Taking and deposits previously made is hereby approved, ratified and confirmed.
- 7. The sums paid to the Respondents, Rolando Ruben Ramos and Ana Maria Valdivia, represents full and final compensation for the taking of Parcel 4, and the Respondents will not seek any further monies from the Petitioner in this cause, except as specifically set forth herein.
- 8. The Court reserves jurisdiction to enforce the terms of this judgment, over supplemental proceedings, if any, pursuant to Florida law.


