Summary: In January 2010, staff provided a comprehensive review of all the boards and commissions ("committees") that the Board of County Commissioners (BCC) currently has some level of participation on and/or in. The January report also included results from an August 2009 survey to current advisory board members and departmental staff liaisons on issues such as time/cost associated with staffing the committee, length of meetings, frequency of meetings, duration of meetings, etc. Following the presentation, the BCC directed staff review all the boards with the goal being to reduce the number of committees. Today's workshop will present staff's findings and recommendations. The BCC has also expressed concerns regarding the Sunshine Law and Code of Ethics as it relates to committees, and staff will present an overview on these policies. Countywide (TKF)

Background and Policy Issues: In an effort to encourage citizen input and/or obtain technical experience in specific areas, the BCC over a considerable period of time has created and been served by a number of advisory boards, task forces, committees and authorities. BCC established committees are governed by Resolution R95-1806. State and federal governments have also mandated creation of some committees, advisory boards, etc. for various reasons. These committees are governed by their respective statutes. Appointments to these numerous committees greatly vary. The process and procedures for appointments to committees has not been covered in this Report.

Sunshine Law Overview

All meetings of public agencies at which official acts are taken must be open to the public.

The term “official acts” includes not only the final act of the public agency, but **every step in the decision making process** which leads to the final act.

Personal Responsibility

The Sunshine Law applies to you because of **your role in the decision making process** - the recommendations made by this group will inform the ultimate decisions, or “official acts” taken by one or more public agencies.

The law is **broadly construed** to ensure all decision making is open to the public. Courts have consistently found that the law is violated any time actions are taken to evade the open meeting requirement. This includes voting by secret ballot, straw polls, or meetings between one or more board members in private to discuss matters that will likely come before the board they serve.

Agency Responsibility

There must be **reasonable notice** of all meetings – sufficient to inform and enable interested persons so they can attend.

The meeting must be held at a place **accessible to the public**.

Minutes must be recorded and made available to the public

Consequences

Knowingly violating the Sunshine Law is a **second degree misdemeanor** = \$500/6mos jail, or both.

Violations are also subject to \$500 **civil penalty**.

Agency decisions linked to violation **can be rendered void**, although in some situations, decisions have been reinstated after full, public airing of the decision at issue.

Agency must **pay attorney’s fees and costs** to person who successfully alleges Sunshine Law violation
