I. EXECUTIVE BRIEF

Motion and Title: **Staff recommends motion to approve:** Amendment No. 3 to the annual Contract for environmental assessment services with Dunkelberger Engineering & Testing, Inc., (R2007-1809) for professional consulting services on a continuing contract basis.

Summary: Dunkelberger Engineering & Testing, Inc., was selected to provide professional consulting services for Annual Environmental Assessment Services. The Board approved an annual contract on October 16, 2007. The original contract provided for an initial two (2) year term with two (2) - one (1) year renewal options. Amendment No. 3 would provide for services during the second renewal period. Dunkelberger Engineering & Testing, Inc. has a Small Business Enterprise (SBE) participation goal of 15%. During the three years of the contract, Dunkelberger Engineering & Testing, Inc. has achieved 15.2% participation. Dunkelberger Engineering & Testing, Inc. has achieved 15.2% participation. Dunkelberger Engineering & Testing, Inc. is a Palm Beach County company. (Capital Improvements Division) <u>Countywide</u> (JM)

Background and Justification: In accordance with Board adopted procedures pursuant to Florida Statute 287.055 (Consultants Competitive Negotiation Act), Dunkelberger Engineering & Testing, Inc. was one of three firms selected to perform professional consulting services on a continuing contract basis. Work is authorized through individual task agreements when required during the term of this contract. The initial contract term is for two years and the original Board action allowed for two additional (1) one year renewals. Amendment No. 3 will provide services during the second renewal period and would be the fourth year of the contract. It is the consensus of Facilities Development & Operations that Dunkelberger Engineering & Testing, Inc. has successfully provided the professional services required by the County in a timely manner. They are in good standing and wish to continue to provide professional services. Amendment No. 3 will maintain the continuous professional services required by the County. During the two years of the contract, Dunkelberger Engineering & Testing, Inc. was awarded \$125,599 in Consultant Service Authorizations.
