#### I. EXECUTIVE BRIEF

MOTION AND TITLE: Staff recommends motion to approve: a grant adjustment notice for the Edward Byrne Memorial JAG Program grant for the Program Monitoring and Evaluation Project (R2010-0647) to extend the expiration date from September 30th, 2010 through December 31st, 2010.

**SUMMARY:** The Criminal Justice Commission (CJC) requested the use of \$160,212 from the Florida Department of Law Enforcement (FDLE) FY09 Edward Byrne Memorial Justice Assistance Grant (JAG). There is no match requirement for JAG funds. All unexpended grant funds will be administratively carried forward to FY 2011. Countywide (GB)

BACKGROUND AND POLICY ISSUES: The FLDE, Office of Criminal Justice Grants administers the Edward Byrne Memorial Justice Assistance Grant (JAG) Program. The JAG Program is a blend of the previous Byrne Formula and Local Law Enforcement Block Grant (LLEBG) Programs which allows local governments to support a broad range of activities to prevent and control crime based on local needs and conditions. The grant applications were executed by the BCC on August 18, 2009 as resolutions: R2009-1321 (for the Criminal Justice Commission) and the grant was filed and received on April 20, 2010 as resolution R2010-0647. This grant applicant was initiated by the request from the BCC to determine the effectiveness of specific programming funded in whole or in part by the Criminal Justice Commission. As such, the funding will support the Research and Planning Unit's research and evaluation mandate. The Research Assistant will work with the Research Planning Manager assigned to manage and implement the project. The Criminal Justice Commission also has the authority by ordinance to review, research, and evaluate existing systems and programs within the scope of the Criminal Justice Commission (sec 2-218 Authority). It is by this authority that the Criminal Justice Commission has asked staff to address the following broad question for programs funded during the 2010 fiscal year (October 1, 2009 to September 30, 2010). A request for extension of the grant was sent to FDLE and approved on July 19, 2010 with the following conditions: "The grant period is extended through December 31, 2010."

How are funds spent by various agencies and organizations managing programs and activities supported by the Criminal Justice Commission? Addressing this question will help members prioritize current and new funding for programs in crime prevention, law enforcement, courts and corrections domains.
