PALM BEACH COUNTY NOTICE OF GENERAL CONSULTING SERVICES DESIRED

Pursuant to the Florida Statutes Section 287.055 and Procedures of Palm Beach County, Notice is hereby given that Letters of Interest/Statements of Qualifications are requested from qualified firms to provide Environmental Assessment/Architectural/Engineering/Construction Management and Land Development Professional Services for Palm Beach County Department of Airports. The services are to be carried out in accordance with Federal Aviation Administration (FAA), Florida Department of Transportation (FDOT), and all applicable Federal, State, and Local Codes, Regulations, Ordinances, and Policies.

The Consultant(s) selected by the County to perform these Professional Services will be awarded a contract for two (2) years with an option of two (2) one (1) year renewals at the County's discretion. The projects to be performed by the Airports' Design Consultants will be in accordance with the approved Airport Master Plan and those projects required to enhance the level of service, safety, security, capacity, and financial viability of the Palm Beach County Airport System. The selected Consultant(s) will scope, negotiate and enter into individual agreements for services with the County on a project-by-project basis during the term of the contract.

Services to be performed by the Consultant(s) may include, but are not limited to, the following:

- Development Program Administration and Management (CIP Programming, Consulting and Implementation).
- Aviation Planning, including Air Service Studies and Financial Analyses
- Land Use Planning, Land Acquisition, Market Assessment and Land Development Consulting Services.
- Horizontal Infrastructure Design, such as General Civil and Airfield Electrical Design of Runway, Taxiway and Aircraft Parking Apron Facilities as well as Site Development and Roadway Facility Planning and Design.
- Vertical Facility Design, such as Architectural, Mechanical, Electrical, Structural and Landscaping Design of Airport-related and Ancillary Facilities.
- Facilities Inspection.
- Stormwater and Environmental Permitting and Agency Coordination.
- Program Management/Construction Management, Administration and Coordination.
- Quality Assessment and Quality Assurance Reviews.
- Aviation/Airport Information Technology and Geographic Information System (GIS) Services
- Environmental Assessment (EA) preparation, and other environmental planning and analysis, as needed, to support future development.

Interested consultants shall submit their qualifications relating to the above-mentioned services.

The firms or individuals selected by the County will enter into a non-exclusive agreement with the Department of Airports and will be expected to satisfy the County's applicable Disadvantaged Business Enterprise (DBE) and Insurance Requirements. The DBE participation goal for this project is a minimum of <u>25%</u>. A list of proposed Palm Beach County certified DBE's must be submitted, and associated DBE certification forms shall be submitted with the Letter of Interest/Statement of Qualifications.

Qualifications packages for the professional services advertisement must include all requested information and must be in accordance with the most recent administrative procedure for awarding of consultant contracts adopted by Palm Beach County. All team members are required to be certified by Palm Beach County. Firms must be Consultant's Competitive Negotiations Act (CCNA) certified <u>prior</u> to submission of qualifications, if required by Florida Statute. "Firm" means any individual, firm, partnership, corporation, association or other legal entity permitted by law to practice architecture, landscape architecture, engineering or land surveying and mapping in the State. Additionally, any firm desiring to be considered as a DBE firm must be certified by the Department of Airports <u>or</u> the Unified Certification Program (UCP) <u>prior</u> to the submission of qualifications.

To be considered, the firm or individual must have provided similar services for air carrier and general aviation airports and be familiar with Federal Aviation Administration, Florida Department of Transportation, Palm Beach County, and all Local/Regional Planning Codes, Regulations and Laws. In addition, the firms or individuals must be familiar with Federal, State, and Local Regulatory Agencies and the permitting requirements of these agencies.
