I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:

- A) A Budget Amendment in the amount of \$100,000 in the Public Building Improvement Fund recognizing revenue received from the Governor's Council for Community Health Partnership (GCCHP) and increasing the project budget for furniture, fixtures and equipment (FF&E) expenditure, and;
- B) Change Order No. 1 to Catalfumo Construction, Ltd. (R2007-1217) increasing the contract amount by \$100,000.

Summary: On November 10, 2009, The MacArthur Foundation awarded a grant in the amount of \$250,000 to the GCCHP in support of the Ten-Year Plan to End Homelessness in Palm Beach County. The terms and conditions of this grant included \$100,000 to be used for renovation, furnishings and equipment for the Homeless Resource Center located at 1000 45th Street, West Palm Beach. The funds for the Homeless Resource Center were transferred from the GCCHP account to the County. Change Order No. 1 will increase the contract by \$100,000 in order to purchase the designated furniture, fixtures and equipment for the Homeless Resource Center. (Capital Improvements Division) District 7 (JM)

Background and Justification: The Homeless Advisory Board (HAB) was established by the County Commission in 2007. The BCC formally adopted the Ten-Year Plan to End Homelessness in Palm Beach County, in September 2008. The HAB's focus is now directed toward the Plan's implementation which is being aggressively pursued by its seven committees. Development of a Homeless Resource Center (HRC) is one of the Action Steps of the Plan. The HRC will serve as a hub for homeless service providers, access to health care and mental health and substance abuse treatment assessments as well as provide interim housing. A request was made to the MacArthur Foundation for support in developing a Homeless Resource Center (HRC) that would serve as the entry point for individuals and families to end their homelessness. Funding, in the amount of \$100,000, was granted to the Community Foundation to be used for furnishings, fixtures, equipment and renovations for the HRC. This amount was transferred to the GCCHP, as the non-profit recipient and a check written to Palm Beach County to be used for the Homeless Resource Center. Catalfumo Construction, Ltd. was awarded the construction contract for this project on August 17, 2010 (R2010-1274).


