I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 2 to Contract with Knight Electric Co., Inc. (R2009-2128) to implement the first renewal of an annual Electrical contract with a maximum value of \$1,000,000.

Summary: Amendment No. 2 is a renewal to the Annual Electrical Contract which was awarded to Knight Electric Co., Inc. as one (1) of six (6) approved contractors. Each work order is bid among the six (6) contractors with the lowest responsive annual contractor awarded the work order. The annual Electrical contract is an indefinite-quantity contract and this renewal has a maximum value of \$1,000,000. The renewal term is twelve (12) months or until \$1,000,000 in work orders are issued. Staff is bringing forward the amendment at this time based on expiration of the term. All terms of the original contract remain in effect. This is the first of four (4) extensions allowed by the Contract. The Small Business Enterprise (SBE) participation goals for the Electrical contracts are 15%. Knight Electric had \$14,159 in work orders under this contract during the last term and their participation for work orders issued to date is 100%. Knight Electric Co., Inc. is a certified SBE contractor and is a Palm Beach County company. This is a bond-waiver contract. (FD&O Admin) Countywide (JM)

Background and Justification: Amendment No. 2 is the first renewal to the Annual Contract— Electrical which was awarded to Knight Electric Co., Inc. on December 15, 2009, as one (1) of six (6) Annual Electrical Contractors. The contractor will continue to perform as an annual Electrical contractor for implementation of electrical equipment repairs and/or replacements. The annual Electrical Contract is an indefinite-quantity contract and this renewal has a maximum value of \$1,000,000 among the pool of Annual Electrical Contractors. The renewal term is twelve (12) months or until the renewal limit of \$1,000,000 is reached.

AMENDMENT #2 TO ANNUAL ELECTRICAL CONTRACT

This Amendment No. 2 dated December 15, 2010, to the Contract (R2009-2128) dated December 15, 2009, by and between Palm Beach County, a political subdivision of the State of Florida, by and through its Board of Commissioners, hereinafter referred to as the COUNTY and Knight Electric Co., Inc., a corporation authorized to do business in the State of Florida, hereinafter referred to as the CONTRACTOR.

The contract provided that Contractor would act as one (1) out of a pool of six (6) approved annual Electrical contractors working within the annual capacity as established below:

Amendment No. 2: 1) extends the term of the original contract through December 14, 2011, 2) increases the total dollar value by \$1,000,000.00 for a new total contract value of \$2,000,000.00, and 3) incorporates the following language:

Palm Beach County has established the Office of the Inspector General, Ordinance R2009-049, as may be amended. The Inspector General's authority includes but is not limited to the power to review past, present and proposed County contracts, transactions, accounts and records, to require the production of records, and audit, investigate, monitor, and inspect the activities of the contractor, its officers, agents, employees, and lobbyists in order to ensure compliance with contract specifications and detect corruption and fraud. All contractors and parties doing business with the County and receiving County funds shall fully cooperate with the Inspector General including receiving access to records relating to Bid or any resulting contract. Except as amended herein, all provisions of the existing contract shall remain in full force and effect.
