I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Budget Transfer of \$75,000 within the Park Improvement Fund from the Florida Boating Improvement Program reserve to South County Regional Park Boating Center.

Summary: This budget transfer will provide the funding necessary to complete construction of the South County Regional Park Boating Center. Funding is from the Park Improvement Fund Florida Boating Improvement Program reserve. <u>District 5</u> (AH)

Background and Justification: South County Regional Park is an 855 acre regional park located west of Boca Raton. The boating center project includes the construction of boat ramps, staging docks, floating docks, boat rental slips and water access support infrastructure for public access to the park's 100+ acre lake system. In conjunction with these project elements, the site will be improved to create a boating beach area, canoe kayak launch, and shoreline picnicking area. Pedestrian pathways, car and boat trailer parking, and fencing will be constructed, and new landscaping and sod will be added to enhance this freshwater boating facility. The boating center was designed as part of Phase III of the park's development and construction began last summer. Current funding for this project is from the Florida Boating Improvement Program and Boat Ramp Improvements Program.
