I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to adopt: A Resolution abandoning Tract A, a 25 foot wide right-of-way within Eternal Light Memorial Gardens, Plat IV as recorded in Plat Book 69, Pages 6-7, Public Records of Palm Beach County, Florida.

SUMMARY: Adoption of this Resolution will allow the petitioner to vacate the public interest in the right-of-way to further develop the cemetery. The petition site is located on the east side of State Road 7, approximately 11/2 miles south of Boynton Beach Boulevard.

Background and Policy Issues: The owner/petitioner, Mil-Dell, Ltd, a limited partnership, wants to abandon the public interest in the right-of-way so they can further develop the cemetery.

Utility service providers have no objection to the vacation.

Privilege Fee Statement: In accordance with the exemptions in the Right-of-Way Abandonment and Plat Vacation Ordinance 86-18, as amended, Section V, (6), b, the petitioner is the original gratuitous conveyor of the subject right-of-way, therefore not subject to a privilege fee.




