

Eric Malkin is a current at-large member of the Fair Housing/Equal Employment Board. He was appointed to the board on April 6, 2010 to complete a term that expires on January 9, 2011. Mr. Malkin has expressed an interest in reappointment and has met the attendance requirement during his current term. The board is composed of nine (9) members. Seven members are district appointments and two (2) are at-large. The Ordinances require that the appointees should reflect, to the greatest extent possible, representation from the protected groups identified in the Ordinances and who have experience and interest in equal opportunities. The board meets quarterly. memorandum was sent to the Board of County Commissioners on December 8, 2010. Countywide (TKF)

Background and Justification: The Board of County Commissioners enacted Ordinances 95-31 and Ordinance 90-1, as codified in Sections 2-261 through 2-313 of the Palm Beach County Code and Sections 15-36 through 15-64, respectively, establishing the Fair Housing/Equal Employment Board. This board serves as a quasi-judicial body empowered to hear and decide upon the merits of employment and housing discrimination complaints investigated by the Office of Equal Opportunity. The board meets quarterly. The Board consists of 9 members all seats are currently filled and a diversity of White: 4 (45%), Black: 4 (45%) and Hispanic: 1 (10%). The gender ratio (female: male) is: 1.5:1. This nominee is a Caucasian male.

Pursuant to the Policies and Procedures Manual Board Appointments, the Department requested that the Chair and members of the Board of County Commissioners submit nominees to for this at-large position.


