Summary: The Board of County Commission (BCC) approved the County's FY 2010-2011 Action Plan for Community Development Block Grant (CDBG), Emergency Shelter Grant (ESG) and Home Investment Partnership (HOME) on July 20, 2010. The Agreements with HUD were executed by the BCC Chairman. Ratification by the BCC of the Chairman's signature is required to bring the Agreements and Amendments into Compliance. No local match is required to implement the CDBG program; however, the ESG and HOME programs have matching requirements. The ESG Program matching requirements of \$299,679 (100%) is met through a cash or in-kind contribution by each agency receiving this funding, and the HOME matching requirement of \$694,419.75 (25%) will be met from program income which is still being earned under the State Housing Initiatives Partnership Program (SHIP). Countywide (TKF)

Background and Justification or Background and Policy Issues: These Funding Approval/Agreement Forms constitute the contracts with HUD which makes \$10,428,309 in federal funds available to the County's line of credit with the U.S. Treasury.



WHEREAS, **HUD and Palm Beach County** now desire to amend the **GRANT AGREEMENT** in order to incorporate the award terms established by OMB;



**FY 2010 LOCAL GOVERNMENT GRANT AGREEMENT
EMERGENCY SHELTER GRANTS PROGRAM**

This Grant Agreement is made by and between the United States Department of Housing and Urban Development (HUD) and Palm Beach County the Grantee, for FY 2010 of the Emergency Shelter Grants Program in the amount of **\$ 299,384**. This grant was authorized by Subtitle B of Title IV of the McKinney-Vento Homeless Assistance Act, 42 USC 11301 (1988), as amended (the "Act"). In addition, the grant operates through HUD's regulations at 24 CFR Part 576, as now in effect and as may be amended from time to time, which are incorporated as part of this Agreement.

In reliance upon the Consolidated Plan and certifications, the Secretary agrees, upon execution of the Grant Agreement, to provide the Grantee with the agreed grant funds. The grantee must comply with requirements for record keeping and annual performance reporting to HUD within 90 days after the close of its consolidated program year, as required by 24 CFR 91.520. This includes the periodic information collected through HUD's Integrated Disbursements and Information System (IDIS). The grantee's IDIS reporting must include information on grant activities, project sponsors, project sites, and beneficiaries (including racial and ethnic data on participants). This information will be used for program monitoring and evaluation purposes.

The grantee agrees to comply with all applicable laws and regulations in distributing funds provided under this Grant Agreement and to accept responsibility for ensuring compliance by recipient entities which may receive funding assistance.





WHEREAS, HUD and Palm Beach County now desire to amend the **GRANT AGREEMENT** in order to incorporate the award terms established by OMB;



Reg. 55671 (Sept. 14, 2010) (to be codified at 2 CFR part 25), and Appendix A to Part 170—Award Term, *Requirements for Federal Funding Accountability and Transparency Act Implementation*, 75 Fed. Reg. 55663 (Sept. 14, 2010) (to be codified at 2 CFR part 170).


