## I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: A Contract with Florida Blacktop, Inc. (Blacktop), in the amount of \$388,592.83 for the construction of Congress Avenue Access to South County Intermodal Center (Project).

**SUMMARY:** Approval of this Contract will allow Palm Beach County (County) to issue a Notice to Proceed to Blacktop, a Broward County company, to begin construction of the Project. The County's Small Business Enterprise (SBE) goal for all projects is 15% overall, but the responsive bidders cannot be ranked for SBE compliance for this Project due to federal funding restrictions. The federally required non-mandatory Disadvantaged Business Enterprise (DBE) goal for the project is 8.18%. The SBE and DBE participation proposed for the Project by Blacktop is 2.3% and 8.0% respectively.

### District 7 (MRE)

**Background and Justification:** Bids for the Project were received by the Engineering Department on December 16, 2010. Blacktop was the lowest responsive, responsible bidder. This is a federally funded project, and the responsive bidders cannot be ranked for SBE compliance due to federal funding restrictions. DBE participation cannot be utilized in determining the lowest responsive responsible bidder, and therefore does not affect the federal funding. Contract time for this work is 150 calendar days.



### **RESOLUTION NO. R2011-**

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA **REVISING THE PREVIOUS** INTEREST RATE ON RESOLUTION R-2009-1544 FOR THE SPECIAL ASSESSMENT SUN COURT DRAINAGE AND PAVING IMPROVEMENTS, SECTION 18, TOWNSHIP 42 SOUTH, RANGE 43 EAST, PAVING IMPROVEMENT PROJECT, PURSUANT TO A PUBLIC HEARING HELD THEREON.

WHEREAS, a Resolution (R-2009-1544) confirming the special assessment process for Sun Court was approved on September 15, 2009.

**WHEREAS**, this resolution will amend the original assessment roll by reducing the interest rate on payments made over the 20 year period or less as determined by the property owner of each property assessed.

WHEREAS, the property owners have the opportunity to pay off the entire assessment within 30 days of notice from the tax collectors office without incurring any interest; and

WHEREAS, the remaining assessments incur interest after the 30 day pay off period;

and

WHEREAS, the interest rate on the previous Resolution (R-2009-1544) of 6.5 percent has been revised to 5.5 percent; and

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, THAT:

The Special Assessment Roll for the Sun Court Drainage and Paving Improvements, Section 18, Township 42 South, Range 43 East, as on file in the Clerk of this Board is attached hereto as EXHIBIT II and is hereby approved and confirmed with a revised interest rate of 5.5 percent and shall be recorded by the Clerk of the Board of County Commissioners in a special book to be known as "The Improvement Lien Book" and the record of the lien in said book shall constitute prima facie evidence of the validity of said lien.

1. The said special assessments are hereby made upon all parcels of land described in said Special Assessment Roll in the amount shown thereon.

2. Pursuant to Ordinance No. 94-11 as amended by Ordinance No. 95-53, the following project is hereby approved: Sun Court Drainage and Paving Improvements, Section 18, Township 42 South, Range 43 East, Palm Beach County, Florida.

3. The said special assessments are hereby made upon all parcels of land described in said Special Assessment Roll (EXHIBIT II) in the amount shown thereon.

## RESOLUTION NO. R-2011-March 15, 2011

4. Pursuant to Ordinance No. 94-11 as amended by Ordinance No. 95-53, any and all special assessments made pursuant to this Resolution, which have not been paid in full within thirty (30) days after notice of completion of the subject improvements for which said assessment was made, shall be subject to interest at a rate of five and one-half (51/2 %) percent per annum from the date of the acceptance of said improvement by Palm Beach County and shall be payable in twenty (20) equal annual installments.

5. The total cost of the paving and drainage improvements for the Sun Court drainage and paving project is \$458,571.58 of which the MSTU program funded \$97,879.25 the residents are being assessed \$97,879.25 through a special assessment and the Office of Community Revitalization funded \$262,813.08.

6. Pursuant to Section 21 of Ordinance No. 94-11 as amended by Ordinance No. 95-53, if any special assessment made under this Resolution shall be either in whole or part vacated or set aside by the judgment of any court, or the Board of County Commissioners, it shall be satisfied, that any such assessment is so defective that the same cannot be enforced or collected, or if the Board will have omitted to make any such assessment when it might have done so, the Board of County Commissioners will take all necessary steps to cause a new assessment to be made for any improvement against any property specially benefited by such improvement.

7. The Board of County Commissioners further finds that each parcel listed on EXHIBIT II will obtain a special benefit which is at least equal to the amount of special assessment made against each such parcel. RESOLUTION NO. R-2011-March 15, 2011
