EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: A Task Agreement for \$117,789 against the Annual Structural Services Agreement, R2011-0174, with Bridge Design Associates, Inc. dated February 15, 2011 for the design phase of the Palmetto Park Bascule Bridge Hydraulic Machinery Project, Project No. 2011905.

SUMMARY: Approval of this Task Agreement will authorize Bridge Design Associates, Inc. to prepare plans and technical specifications for structural modifications to the existing bridge, and provide project management utilizing a sub-consultant with mechanical and electrical engineering expertise. Once designed, the new system will provide upgraded technology as well as incorporating current American Association of State Highway and Transportation Officials standards for hydraulic and electrical systems.

District 4, (MRE)

Background and Justification: Bridge Design Associates, Inc. will prepare plans and technical specifications under the Annual Structural Engineering Services Agreement, approved by the Board of County Commissioners (BCC) on February 15, 2011, Resolution No. R2011-0174. The existing hydraulic system used to raise and lower the bridge must be repaired and upgraded in order to continue operation of the bridge. It is estimated that the actual work will cost approximately \$900,000.

Staff recommends that the BCC approve the attached Task Agreement.



December 2, 2010, attached hereto as a part of Exhibit 'A'

NOW, THEREFORE, THIS INDENTURE WITNESSETH: That for and in consideration of the mutual benefits to flow from each to the other, the parties hereto agree as follows:

- 1. The **CONSULTANT** agrees to provide professional services as described in Exhibit "A" of the Agreement known as "SCOPE OF WORK".
- 2. The CONSULTANT agrees to "CERTIFICATION" statements as described in Exhibit "B" of the Agreement.
- 3. The **CONSULTANT** agrees to Minority/Women Business Enterprise (S/M/WBE) Participation as described in Exhibit "C" of the Agreement, and Letters of Interest as described in Exhibit "D".
- 4. The **COUNTY** agrees to pay the **CONSULTANT** a fee of One hundred seventeen thousand seven hundred eighty nine dollars and no/cents, which includes fees paid to subconsultants as outlined in Exhibit "A".
- 5. The CONSULTANT agrees to indemnify, defend and hold harmless the COUNTY against all claims that may arise as a result of negligence, wrongdoing, misconduct or want of care by the CONSULTANT.
- 6. The CONSULTANT agrees to the Conflict of Interest Disclosure form, as outlined in Exhibit "E".

Supplements and Amendments thereto, shall remain in full force and effect.

Bridge Design will provide the structural modifications to the existing bridge as well as the project management to coordinate the various disciplines.

The project will require mechanical and electrical engineering. Bridge Design will utilize Hardesty and Hanover, LLP to provide that expertise. The scope of services provided by Hardesty and Hanover are as follows:
