Motion and Title: Staff recommends motion to approve:

A) Budget Amendment of \$110,000 in the School Impact Fee Zone 2 Account-Contributions To Other Governmental Agencies.

B) Budget Amendment of \$341,000 in the School Impact Fee Zone 3 Account-Contributions To Other Governmental Agencies.

Summary: These budget amendments in the school impact fee accounts recognize additional school impact fee revenues collected in FY 2011 and allow the County to appropriate and remit the revenues to the Palm Beach County School District in accordance with Article 13 of the ULDC. (Countywide) (LB)

Background and Policy Issues: Article 13 of the ULDC provides for a school impact fee which requires new development to pay its fair share for growth. The Impact Fee Office is responsible for the collection, accounting and disbursal of funds to the School District. These budget amendments allow the County to remit \$1,283,627 in school impact fees to the School District. School impact fee revenues can only be used for capacity related capital needs within the school zone the revenues were collected.
