#### **I. EXECUTIVE BRIEF**

# Motion and Title: Staff recommends motion to approve:

- A Contract with Rosso Paving & Drainage, Inc. (Rosso), the lowest responsive, responsible bidder in the amount of \$421,312.80 for the construction of Congress Avenue & Park Avenue Intersection Improvements (Project); and
- B) A Budget Amendment of \$9,580 in the Road Impact Fee Fund Zone 1 to recognize funding from AT&T for utility reimbursable work and appropriate it to Congress Avenue & Park Avenue Intersection Improvements.

**SUMMARY:** Approval of this Contract and Budget Amendment will allow Palm Beach County (County) to issue a Notice to Proceed to Rosso, a Palm Beach County company, to begin construction of the Project. The County's Small Business Enterprise (SBE) goal for the Project is 15% overall. The SBE participation committed for the Project by Rosso is 51.49%.


