I. EXECUTIVE BRIEF


Motion and Title: Staff recommends motion to approve: Amendment No. 1 to the Agreement (R-2010-1324) with the law firm of Edwards Angell Palmer & Dodge, LLP ("Attorney"), to provide bond counsel and related legal services for the estimated \$64 Million Public Improvement Revenue Refunding Bonds, Series 2011 (Convention Center Project) (the "Bonds").

Summary: The law firm was selected as bond counsel for the above financing by the Board at the May 17, 2011 meeting. This Amendment No. 1 confirms that selection by amending the existing Agreement for bond counsel and related services between Palm Beach County and the law firm. Payment for the legal services in connection with the bond issuance will be as provided for in the Agreement. Countywide (PFK).
