





**AMENDMENT TO TELEPHONE CRISIS HOTLINE SERVICES CONTRACT**

**THIS AMENDMENT TO THE 211 PALM BEACH/TREASURE COAST, INC. TELEPHONE CRISIS HOTLINE SERVICE CONTRACT** (Document No. R2010-1065, dated June 29, 2010) made and entered into at West Palm Beach Florida, on this 31<sup>st</sup> day of MAY, 2011 by and between PALM BEACH COUNTY, a political subdivision of the State of Florida hereinafter referred to as "COUNTY" and 211 Palm Beach/Treasure Coast, Inc. hereinafter referred to as the AGENCY, a not-for-profit corporation, entitled to do business in the State of Florida, whose address is PO Box 3588, Lantana, FL 33465

**WITNESSETH:**

**WHEREAS**, the need exists to amend the contract to extend the contract period to September 30, 2011 and increase the dollar amount to \$52,500.

**NOW THEREFORE**, the above named parties hereby mutually agree that the Contract entered into on June 29, 2010 is hereby amended as follows:

- I.** To continue to provide over the phone emergency crisis counseling services through the Violent Crime Rape Crisis Hotline until September 30, 2011.
- II.** A new Schedule for Payment Exhibit "B" attached hereto showing the new total budget. This shall replace the original Exhibit "B" in its entirety.
- III.** Increase funding for Telephone Crisis Hotline by \$10,500 for a new total not to exceed \$52,500.

**OTHER PROVISIONS**

All provisions not in conflict with this Amendment are still in effect and are to be performed at the same level as specified in the Contract.


Palm Beach County has established the Office of the Inspector General in Ordinance 2009-049, as may be amended, which is authorized and empowered to review past, present and proposed County contracts, transactions, accounts and records. The Inspector General has the power to subpoena witnesses, administer oaths and require the production of records, and audit, investigate, monitor, and inspect the activities of the CONSULTANT, its officers, agents, employees, and lobbyists in order to ensure compliance with contract requirements and detect corruption and fraud.

Failure to cooperate with the Inspector General or interference or impeding any investigation shall be in violation of Ordinance 2009-049, and punished pursuant to Section 125.69, Florida Statutes, in the same manner as a second degree misdemeanor.




