Motion and Title: Staff recommends motion to: A) Accept on behalf of the Palm Beach County Sheriff's Office, a Grant Modification with the Office of National Drug Control Policy, to provide an additional \$37,500 in FY2009 reimbursable funding, for the Palm Beach County Multi-Agency Diversion Task Force, B) Approve a budget amendment of \$37,500 in the Sheriff's Grant Fund.
