SUMMARY : Finalization of the assessment roll for the Project from Arden Street north to Lake Worth Road, (Section 30, Township 44 South, Range 43 East) is needed so the assessment payments can be processed and collected by the Tax Collector's Office. Coconut Road will be reclassified from a County courtesy maintained roadway to a County maintained roadway.

Background and Justification: On September 14, 2010, the County held a Public Hearing, and adopted Resolution R2010-1453, an assessment roll for the Project. The final cost of \$25 per abutting foot is the same as the original estimated total costs based on \$25 per abutting foot for Countywide Community Revitalization Team Area projects, payable over 20 years. Upon approval of this item the Tax Collector's Office will process and collect the assessments from the property owners. Coconut Road has been constructed to County standards and will be perpetually maintained by the County.


