MOTION AND TITLE: Staff recommends motion to approve: A) A Second Amendment to the Interlocal Agreement (R2010-0794) with the Palm Beach County Sheriff's Office (PBSO) to extend the expiration date from September 30, 2011, to September 30, 2012; B) A First Amendment to the Interlocal Agreement (R2010-1927) with the PBSO to extend the expiration date from September 30, 2011, to September 30, 2012.

SUMMARY: The Law Enforcement Planning Council, previously recommended to the Criminal Justice Commission (CJC) and the CJC has previously used grant funds for overtime to support strategic operations of the Gang Task Force. The strategic operations involved in this initiative are ongoing and there are unexpended dollars through no fault of either party.

The continuing strategic operations will be coordinated by the Gang Task Force, which is made up of municipal police departments as well as the PBSO and the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF). This initiative is twofold focusing on stopping the illegal sale and purchase of firearms and combating gang violence. <u>Countywide</u> (GB)

BACKGROUND AND JUSTIFICATION: On July 13, 2006, the BCC provided direction to the Criminal Justice Commission to develop a budget for the Youth Violence Prevention Project including the commitment from local law enforcement jurisdictions to address the increase in violent crime. Strategies to reduce the incident of violent crime include: improving evidence collection methods by establishing countywide standards, increasing the number of multi-agency strategic operations, and acquiring innovative technologies to optimize criminal prosecutions.

SECOND AMENDMENT TO INTERLOCAL AGREEMENT WITH THE BOARD OF COUNTY COMMISSIONERS, PALM BEACH COUNTY, FLORIDA AND PALM BEACH COUNTY SHERIFF'S OFFICE, WEST PALM BEACH, FLORIDA

THIS SECOND AMENDMENT to the Interlocal Agreement (R2010-0794) is made as of the ______ by and between the Board of County Commissioners, Palm Beach County, Florida, herein referred to as the COUNTY, and the Palm Beach County Sheriff's Office, West Palm Beach, Florida, herein referred to as the PBSO.

WITNESSETH

WHEREAS, The Criminal Justice Commission (CJC), upon direction from the Board of County Commissioners (BCC), wishes to provide continued support to the Youth Violence Prevention Project which addresses the increase in violent firearm crimes; and

WHEREAS, the Palm Beach County Sheriff's Office has the lead in Gang Task Force for Palm Beach County; and

WHEREAS, the COUNTY agreed to reimburse PBSO for the expenses of strategic operations of the Gang Task Force, up to the amount of \$75,000 from October 1, 2009 through September 30, 2011 as amended; and

WHEREAS, the strategic operations involved in this initiative are ongoing and there are unexpended dollars through no fault of either party; and

WHEREAS, the parties mutually desire to extend the term of the Agreement until September 30, 2012 or until all funds are expended, whichever occurs first.

NOW THEREFORE, in consideration of the mutual promises contained herein, the COUNTY and the PBSO agree as follows:

- 1. The Term of Agreement is amended to provide that the Agreement shall continue until September 30, 2012 or until all funds are expended, whichever occurs first;
- 2. The COUNTY'S representative/contract monitor during the term of this Agreement shall be Brenda Oakes, whose telephone number is (561) 355-1617.

All other provisions of said Agreement are hereby confirmed, and except as provided herein are not otherwise altered or amended and remain in full force and effect.

THIS FIRST AMENDMENT to the Interlocal Agreement (R2010-1927) is made as of the _____ by and between the Board of County Commissioners, Palm Beach County, Florida, herein referred to as the COUNTY, and the Palm Beach County Sheriff's Office, West Palm Beach, Florida, herein referred to as the PBSO.

WITNESSETH:

WHEREAS, The Criminal Justice Commission (CJC), upon direction from the Board of County Commissioners (BCC), wishes to provide continued support of the Youth Violence Prevention Project which addresses the increase in violent firearm crimes; and

WHEREAS, the purpose of the Youth Violence Prevention Project is to implement a comprehensive strategy that includes the four components of the criminal justice system to prevent and combat gun related youth violence in Palm Beach County; and

WHEREAS, PBSO has the lead in the Gang Task Force for Palm Beach County; and

WHEREAS, the COUNTY agreed to reimburse PBSO for the expenses outlined in the Gang Task Force strategic operations, up to the amount of \$40,616 from October 1, 2010 through September 30, 2011; and

WHEREAS, the Gang Task Force is ongoing and there are unexpended dollars through no fault of either party; and

WHEREAS, the parties mutually desire to extend the term of the Agreement until September 30, 2012 or until all funds are expended, whichever occurs first.

NOW THEREFORE, in consideration of the mutual promises contained herein, the COUNTY and the PBSO agree as follows:

- 1. The Term of the Agreement is amended to provide that the Agreement shall continue until September 30, 2012 or until all funds have been expended, whichever occurs first;
- 2. The COUNTY'S representative/contract monitor during the term of this Agreement shall be Brenda Oakes, whose telephone number is (561) 355-1617.

All other provisions of said Agreement are hereby confirmed, and except as provided herein are not otherwise altered or amended and remain in full force and effect.
