Background and Justification: (Continued from Page 1)

The Agreement (R2010-1944) in the amount of \$4,523,006 with Community Land Trust of Palm Beach County, Inc. (CLT) for the Davis Landings Project was executed on November 16, 2010. Amendment No. 001 provides for necessary changes to the Project Scope, project budget, allowable costs, monitoring inspections, final inspections, updating the monthly program income, the addition of the Buy American requirements, and replacement of updated Exhibits. A Loan Agreement required by Agreement (R2010-1944) was also executed with the CLT on August 3, 2011.

The Agreement (R2010-1124) with the City of Greenacres was executed on March 25, 2010. Amendment No. 003 provides an additional \$6,562.99 in CDBG-R funds and extends the expiration date to October 31, 2011.

The Agreement (R2011-0048) with We Help CDC was executed on October 21, 2010. Amendment No. 001 provides for a reallocation of \$10,000 from administration to inspector's salary.

The Agreement (R2011-049) with the City of Delray Beach was executed on October 28, 2010. Amendment No. 001 provides for a reallocation of \$50,000 from rehabilitation costs to inspector salary.

The Agreement (R2010-1894) with the City of Belle Glade (City) was executed on November 16, 2010. The Agreement provides \$193,865 in CDBG funds to the City to fund activity delivery costs related to the preparation of files and coordination of the bidding process for rehabilitation and demolition projects undertaken within the City under the countywide housing rehabilitation program and countywide demolition program. The Agreement was slated to expire on September 30, 2011, and most of the available funds are still unspent. The Amendment provides a one (1) year time extension to enable the City to complete the activities contemplated in the Agreement.
