



WHEREAS, the Board of County Commissioners of Palm Beach County, Florida, pursuant to authority in Section 336.09, Florida Statutes, and Ordinance No. 86-18 known as the Palm Beach County Right-of-Way Abandonment and Plat Vacation Ordinance, as amended, and the petition of Palm Beach County, called a public hearing to be held in the County Commissioners' Chambers, at the Governmental Office Complex, West Palm Beach, Florida, on November 15, 2011, to consider and determine whether or not Palm Beach County would vacate, abandon, discontinue and close, renounce and disclaim any right or interest of the Public in and for that portion of a 30' right-of-way located between Tract 13 and Tract 20 and a 50' ROW located between Tract 36 and Tract 37 in Block 21 of Palm Beach Farms Co. Plat No. 3; and

WHEREAS, said petition to vacate was submitted by Palm Beach County; and

WHEREAS, in accordance with Ordinance No. 86-18, as amended, notice of the holding of such meeting was duly published in the Palm Beach Post on October 30, 2011; and

WHEREAS, this Board of County Commissioners did hold said hearing as advertised and determined that such action would not materially interfere with the County Road System and would not deprive any person of a reasonable means of ingress and egress from at least one County, State or Federal highway.

WHEREAS, said rights-of-way were not abandoned due to scrivener's errors in Resolution R72-425, recorded in Official Records Book 2068, Pages 689-691. In paragraph (5) on page 689, the Block should have read 21 instead of 20. In paragraph (8) on page 690, the ROW width read 30' and should have read 50'. Therefore not all
