I. EXECUTIVE BRIEF				
Title: Staff requests direction regarding the results of the public County Charter review process.				
Summary: The Board directed that staff conduct a public County Charter review process. Public Affairs staff solicited and received public input thru public meetings, a dedicated website as well as written and electronic surveys. Staff coordinated 9 informational meetings throughout the county which were publicized in newspaper ads, press releases and the county's online meeting schedule. A total of 144 residents attended the 9 informational meetings. Staff also attended 7 meetings at the request of individual community groups with a total of 200 attendees. A total of 933 surveys were collected and 1,245 comments within the surveys were tabulated and categorized by topic. Countywide (RB)				
Board direction is necessary to move forward with placing any proposed charter amendments on the November 2012 ballot. A proposed charter amendment is put on ballot by passage of an Ordinance by the Board. Proposed charter amendment ballot language is due by noon August 10, 2012 to the Supervisor of Elections office.				
Background and Policy Issues: On January 25, 2011 the Board approved a public charter review process without the establishment of a review committee and on April 5, 2011 the Board directed county staff to conduct a public charter review process for the purpose of obtaining public input regarding possible charter changes. The public charter review process provided information on the history and structure of county government, gave an overview of the county charter, including what it does, how it was enacted and a timeline of amendments since adoption. The structure of county government for all of the charter counties in Florida (20) was also reviewed. The charter has had a total of 13 amendments since it was adopted in 1984, two of which were put on the ballot by petition of the voters.


