<b>Motion and Title: Staff recommends motion to adopt:</b> a resolution of the Board of County Commissioners of Palm Beach County, Florida, amending R-92-13, establishing the policy that Palm Beach County shall not do business with nor appropriate funds for any public or private organization which practices discrimination on the basis of race, color, national origin, religion, ancestry, sex, age, marital status, familial status, sexual orientation, gender identity or expression, or disability.					
<b>Summary:</b> This amended resolution will update the County's non-discrimination in contracting policy so that the protected classes are consistent with the protected classes in the County's Equal Employment Ordinance. Countywide (TFK)					
<b>Background and Policy Issues:</b> On January 7, 1992, the Board of County Commissioners adopted a non-discrimination policy regarding its contracts with private and public entities. After the adoption of that resolution, the County included the policy in all of its contracts with private and public entities. Since that time, the County has enacted the Equal Employment Ordinance which is codified in the Palm Beach County Code 2-261 – 2-313. The Equal Employment Ordinance has additional protected classes that have not been incorporated into the contracting resolution. This amendment will make the policies consistent.

#### **RESOLUTION NO. R-2011-**

THE RESOLUTION OF **BOARD** OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, AMENDING R-92-13, ESTABLISHING THE POLICY THAT PALM BEACH COUNTY SHALL NOT DO BUSINESS WITH NOR APPROPRIATE FUNDS FOR ANY PUBLIC OR **PRIVATE ORGANIZATION** WHICH PRACTICES DISCRIMINATION ON THE BASIS OF RACE, COLOR, NATIONAL ORIGIN, RELIGION, ANCESTRY, SEX, AGE, MARITAL STATUS, **FAMILIAL** STATUS, ORIENTATION, GENDER INDENTITY AND EXPRESSION, OR DISABILITY.

WHEREAS, the Board of County Commissioners of Palm Beach County, Florida wish to state a clear policy that Palm Beach County will not do business with nor appropriate funds for any public or private organization which practices discrimination on the basis of race, color, national origin, religion, ancestry, sex, age, marital status, familial status, sexual orientation, gender identity and expression, or disability, and or:

WHEREAS, since the implementation of this resolution, the County has added additional protected classes to its employment ordinance, and amending this resolution will make the protected classes consistent.

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. Paragraph 1 of Resolution R-92-13 is hereby amended to read as follows: It is hereby the express policy of the Board of County Commissioners of Palm Beach County, Florida that Palm Beach County, Florida shall not conduct business with nor appropriate any funds for any organization that practices discrimination on the basis of race, color, national origin, religion, ancestry, sex, age, <u>familial status</u>, marital status, sexual orientation, <u>gender identity and expression</u>, or disability.
