ASSIGNMENT OF AGREEMENT

THIS ASSIGNMENT OF AGREEMENT ("Assignment") is made effective as of December 1, 2011 by Ruden McClosky P.A. ("Assignor") in favor of Greenspoon Marder, P.A. ("Assignee").

WHEREAS, Assignor and Palm Beach County, Florida ("County") are parties to that certain Agreement for Bond Counsel and Related Legal Services dated August 17, 2010, R-2010-1220 ("Agreement"); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby grant, bargain, sell, assign, transfer and convey unto Assignee all of its right, title and interest in the Agreement, and Assignee agrees to accept such assignment and to be subject to the terms and conditions of the Agreement, provided, however the parties acknowledge that such assignment will not be of full force and effect until the County consents in writing thereto.
