Summary: The Westgate/Belvedere Homes Community Redevelopment Agency (WG/BH CRA) Board consists of seven (7) At-Large members from the general public and local businesses within the CRA boundaries. Ordinance No. 89-6 requires that the Palm Beach County Board of County Commissioners (BCC) appoint the WG/BH CRA Board Commissioners. The WG/BH CRA is seeking to appoint three (3) candidates to complete two (2) unexpired terms and one (1) expired term for Seat No. 1, Seat No. 3, and Seat No. 5. Mr. Christopher Fleming, a property owner, has expressed a willingness to complete the unexpired term of Mr. Joseph D. Peacock who held Seat No. 1 and has resigned. Ms. Cecilia St. Hilaire, a business owner, has expressed a willingness to complete the unexpired term of Mr. Frederick G. Wade who held Seat No. 3 and has resigned. Ms. Ruth Haggerty, a resident, has expressed a willingness to fill expired Seat No. 5, which was held by Mr. Dennis P. Koehler, who had resigned. At the December 12, 2011 WG/BH CRA Board meeting, Mr. Fleming, Ms. St. Hilaire, and Ms. Haggerty were nominated by the Board and residents to be recommended for appointment by the BCC. The Commissioners were notified of the vacancies by the WG/BH CRA on December 13, 2011. District 2 (RB)

Background and Justification: The Westgate/Belvedere Homes CRA was created by the Board of County Commissioners pursuant to Ordinance No. 89-6, adopted in May, 1989 and amended by Ordinance No. 91-50, adopted in March, 1991. The Westgate/Belvedere Homes CRA By-laws provide for board members and the public to nominate prospective candidates for the Westgate Belvedere Homes CRA Board of Commissioners and to forward the nominations to the Palm Beach County Board of County Commissioners for appointment. The Westgate/Belvedere Homes CRA Board consists of seven (7) members seats, four (4) of which are filled currently with a diversity count of Male: 2 (50%); Female: 2 (50%); and White: 4 (100%).

Section 1. AUTHORITY FOR ENACTHENT.

This ordinance is enacted pursuant to the Community
Redevelopment Act of 1969, as smended, Chapter 69-305, Laws of Florida.

Section 2. CREATION OF THE WESTGATE/BELVEDERE HOMES COMMUNITY REDEVELOPMENT AGENCY

There is hereby created a public body corporate and politic to be known as the Westgare/Belvedera Homas Community Redevelopment Agency.

**Hereinafter referred to as the "Agency."

Section 3. MEMBERSHIP

3.01. The agency shall consist of seven (7) commissioners appointed by the Board of County Commissioners. Any person may be appointed as a commissioner if he or she resides or is engaged in business, which shall mean owning a business, practicing a profession, or parforming a service for compensation, or serving as an officer or director of a corporation or other business entity so engaged, within the area of operation of the agency, which shall be coterminous with the area of operation of the county.

3.02. Terms of office of the commissioners shall be for 4 years except that three of the members first appointed shall be designated to serve terms of 1, 2 and 3 years, respectively, from the date of their appointments, and four (4) members shall be designated to serve for terms of 4 years from the date of their appointments. A vacancy occurring during a term shall be filled for the unexpired term. A certificate of the appointment or reappointment of any commissioner shall be filed with the clark of the county, and such certificate shall be conclusive evidence of the due and proper appointment of such commissioner.

3.03. A commissioner shall receive no compansation for his services, but shall be entitled to the necessary expenses, including traveling expenses, incurred in the discharge of his duties, subject to prior approval by the Board of County Commissioners.

3.04. The powers of a community redevelopment agency shall be exercised by the commissioners thereof. A majority of the commissioners shall constitute a quorum for the purpose of conducting business and are recising the powers of the agency and for all other purposes. Action may be taken by the agency upon a vote of a majority of the commissioners present, unless in any case the bylava shall require a larger number.
