#### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** A 120 calendar day contract with Foster Marine Contractors, Inc. (Contractor), the lowest, responsive, responsible bidder, in the amount of \$447,458 for the Glen Ridge Paving & Drainage Improvements (Project), Project No. 2003061-G.

**SUMMARY:** Approval of this Project will provide for the construction of a drainage system for the Glen Ridge area and reconstruction of the roads to coordinate with the storm water improvements. The Contractor is a Palm Beach County business. The construction contract is wholly funded with federal grant funds, therefore the Small Business Enterprise (SBE) Ordinance does not apply to this Project.

## District 3 (MRE)

**Background and Justification:** The bids were received by the Board of County Commissioners on October 4, 2011. The Project will interconnect the existing lakes in Glen Ridge to the West Palm Beach Canal, through the proposed storm sewer system, thus providing a second storm water outfall for the area. Funding for this project was obtained from a Community Development Block Grant through Housing and Community Development (HCD).


