I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: an Amendment to the "Financial Assistance Award" with the U.S. Department of Commerce, Economic Development Administration (EDA) and the Glades Utility Authority (GUA) to add the City of Belle Glade as a co-recipient.

Summary: On January 12, 2010, the Board of County Commissioners (BCC) ratified the signature of the County Administrator on an application for Federal Assistance (SF-424) as "Co-Applicant" with the GUA for Federal Grant funding from the Department of Commerce, Economic Development Administration (R-2010-0139). On April 8, 2010, Palm Beach County was notified that the Grant was approved. A local match requirement of \$1,330,000 will be obtained from previously awarded State and local grants. On May 4, 2010, The BCC ratified a "Financial Assistance Award" with the EDA and GUA in the amount of \$3,990,000 for the design and construction of wastewater infrastructure owned by the GUA, within their utility service area. Water Utilities Department (WUD) will manage the project for the GUA. The project will be funded from WUD's Capital Improvement Fund. The GUA will be reimbursed by EDA for the project costs and repay WUD from these funds. The Amendment is necessary to add the City of Belle Glade as a co-recipient which is necessary since the City of Belle Glade has property rights within one of the project areas. These property rights relate to a reverter clause contained in a deed conveying property from the City of Belle Glade to GUA. District 6 (MJ)

Background and Justification: The Glades Communities have struggled with water quality issues, inadequate sewer infrastructure, lack of revenues and the inability to encourage business growth. This investment is intended to overcome many of the issues related to inflow and infiltration of the wastewater system, enhance regional productivity and innovation, enhance the area's economic base and provide necessary infrastructure to those industries new to the Glades area such as aerospace, pharmaceutical/medical, alternative energy and tourism.

OFFER TO AMEND FINANCIAL ASSISTANCE AWARD (Amendment No. 1)

TO: Glades Utility Authority, Palm Beach County, and City of Belle Glade

WHEREAS, the United States of America, Department of Commerce, Economic Development Administration (herein the "Government") entered into a Financial Assistance Award (herein the "Award") on or about April 7, 2010 with The Glades Utility Authority and Palm Beach County for regional waste water system improvements (herein "Co-recipients"); and

WHEREAS, the City of Belle Glade will retain certain property rights as part of the waste water system improvements that are to be constructed pursuant to this Award. Government regulations require that the owner of property constructed or improved with funds from an award must be an award recipient. For this reason, it is now necessary to add the City of Belle Glade to the Award as a Co-recipient.
