**I. EXECUTIVE BRIEF**

**Motion and Title:** Staff recommends motion to: Adopt Resolution of the Board of County Commissioners of Palm Beach County, Florida, changing the street name of Hayward Terrace to Haywood Terrace, located in Plat Book 53, pages 72 - 77.

**Summary:** Town Villas Homeowners Association has asked the Palm Beach County Board of County Commissioners to rename Hayward Terrace to Haywood Terrace to correct the spelling to that of which the homeowners are accustomed to.

Upon receiving a copy of the approved resolution, PZ&B Staff will implement the name change by notifying appropriate parties and agencies. (District 5) RB

**Background and Policy Issues:** Hayward Terrace is located in the plat of Weitzer PUD Plat 3, recorded in Plat Book 53, pages 72 - 77.

Town Villas Homeowners Association is requesting a street name change from Hayward Terrace to Haywood Terrace to be more consistent with the Hollywood themed names found throughout the development. All property owners whose property abuts the street have signed a petition agreeing to the name change.

This request is consistent with adopted County policies and procedures for vanity street name changes set forth in Resolutions R-74-183 and R-91-1145. Per Resolution R-91-1145, an application fee of \$1,400.00 was received to cover costs associated with name changes. No policy issues are associated with this agenda item.
