## I. EXECUTIVE BRIEF

## Motion and Title: Staff recommends motion to approve:

- A) A 90 calendar day contract (Contract) with AKA Services, Inc. (Contractor), the lowest, responsive, responsible bidder, in the amount of \$321,705 for the Glades Citizens Villas (Project), Project No. 2007905, located near the City of Pahokee contingent upon approval of the Contract Documents by the State of Florida Department of Economic Opportunity (DEO); and
- **B)** A Budget Amendment of \$16,060 in the Capital Outlay Fund to recognize utility relocation reimbursements from Florida Power and Light (\$14,530) and Cable Television (\$1,530), and appropriate it to the Project.

**SUMMARY:** Approval of this Contract will allow for the construction of new storm sewers and drainage structures. After review of the contingent items, AT&T advised that they would protect, adjust and support their facilities (bid items 26 & 27) thereby reducing the total Contract award amount by \$5,000, from the original total of \$326,705. The Contractor is a Palm Beach County business and is applying for SBE certification. The construction contract, except for the utility work, is funded with Federal Grant funds; therefore the Small Business Enterprise Ordinance does not apply to this Project. Approval of this Contract is contingent upon the DEO's approval of the Contract documents.

## District 6 (MRE)

**Background and Justification:** The bids were received by the Board of County Commissioners on December 20, 2011. The Project will improve the overall drainage of the area by upgrading the existing outfall and constructing three additional new outfalls. Coordination with and cooperation by the property owners, utility companies and the City of Pahokee have been essential to the fruition of this Project. Funding for this project was obtained from Disaster Recovery Initiative and Community Development Block Grant through Department of Economic Sustainability.

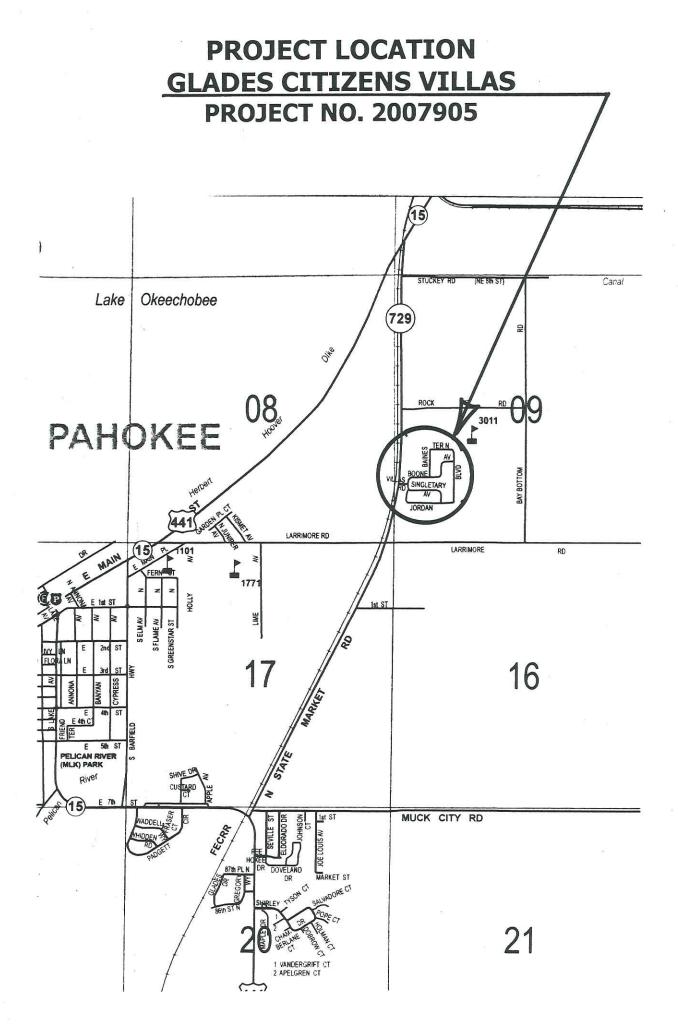
