I. EXECUTIVE BRIEF

Motion and Title: Staff Recommends Motion to approve: Conceptual Alignment 2A (South) for Congress Avenue from Park Lane to State Road 811/Alternate A1A.

SUMMARY: Approval of Conceptual Alignment 2A (South) for Congress Avenue from Park Lane to State Road 811/Alternate A1A, will finalize the alignment and allow the start of the design and right-of-way acquisition process for this portion of Congress Avenue. At the Board of County Commissioners (Board) meeting held on February 28, 2006, the Board approved the alignment of Congress Avenue south of this segment from Northlake Boulevard to Park Lane. Ultimately, over 22 residences will have to be acquired to allow this new road to be constructed.

District 1 (MRE)

Background and Justification: Congress Avenue, north of Northlake Boulevard to Alternate A1A, is presently reflected as an 80 foot right-of-way on the Thoroughfare Right-of-Way Identification Map. The design and construction of this road segment will provide an additional link in the Roadway Thoroughfare System and will reduce traffic congestion at the intersection of Northlake Boulevard and State Road 811/Alternate A1A.

The Board of County Commissioners previously approved Conceptual Alignment 1A, in Segment 1, which begins just north of Northlake Boulevard and ends at Park Lane.

Conceptual Alignment 2A (South) in Segment 2, is contiguous to alignment 1A. It begins at Park Lane, heads north then turns east along Richard Road and ends at State Road 811/Alternate A1A.

Background and Justification: (Continued)

The estimated construction costs for the alignments in segment 2 were essentially the same. However, there was a difference in the right-of-way impacts and costs. Conceptual Alignment 2A (South) was considered to be the most cost effective.


Right-of-way acquisition within the limits of Segment 2 will impact existing residential homes, mobile homes and businesses.

Staff also evaluated the "No Build" option and recommends that the road needs to be built to handle the projected traffic needs for this section of Palm Beach County (County). Approving Conceptual Alignment 2A (South) in Segment 2 at this time will allow the County to proceed with the roadway design and right-of-way acquisition, and allow for the ultimate connection of Congress Avenue to SR 811/Alternate A1A.

A Notice of Public Hearing letter dated February 1, 2012, was sent to all adjacent property owners.


After an analysis of the alignment alternatives, staff recommends approval of Conceptual Alignment 2A (South) in Segment 2.


CONGRESS AVENUE NORTHLAKE BLVD. TO ALTERNATE A-1-A
