I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Work Order No. 2012053-026 in the amount of \$305,266 to construct a pathway on Seminole Pratt Whitney Road from 1700 feet north of Persimmon Boulevard to the "M" Canal utilizing Palm Beach County's (County) Annual Pathway and Minor Construction Contract R2011-1684 (Improvements) with Wynn & Sons Environmental Construction Corporation.

SUMMARY: Approval of this Work Order will provide the contractual services necessary to construct the Improvements. Per County PPM CW-F-0-050, this work order exceeds the threshold relating to staff approvals of contracts, thus requiring the Board of County Commissioners' approval.

Background and Justification: On November 1, 2011, the Board of County Commissioners approved the Annual Pathway and Minor Construction Contract R2011-1684 with Wynn & Sons Environmental Construction Corporation to provide construction of pathway and minor construction for Countywide projects. The County desires to construct the Improvements in accordance with the attached Work Order No. 2012053-026. This construction is fully funded by the FY 08-09 and FY 09-10 Annual Pathway Program.


