I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:

a) a 120 calendar day contract (Contract) with AKA Services, Inc. (Contractor), the lowest, responsive, responsible bidder, in the amount of \$1,265,492 for Limestone Creek Drainage Improvements Phase IIC (Project), Project No. 2011056;

b) a Budget Transfer of \$1,438,179 in the Disaster Recovery Initiative Fund to the Capital Outlay Fund for the Limestone Creek Phase IIC project, and

c) a Budget Amendment of \$1,438,179 in the Capital Outlay Fund to recognize the transfer from the Disaster Initiative Recovery Fund and appropriate it to the project.

SUMMARY: Approval of this Contract will permit the construction of a drainage system for Limestone Creek Road and Mitchell Street; construction or reconstruction of the roads to coordinate with the storm water improvements and provide pedestrian circulation. The Contractor is a Palm Beach County business. The Contract is funded with Federal Grant funds; therefore the Small Business Enterprise Ordinance does not apply to this Project. Approval for award of this Contract has been received from the State of Florida Department of Economic Opportunity (DEO). The budget transfer and amendment allow for the proper accounting of the project in a capital fund. <u>District 1</u> (MRE)

Background and Justification: The bids were received by the Board of County Commissioners on February 28, 2012. The cost of construction is fully funded by a Tropical Storm Fay Grant Disaster Recovery initiative, administered through the Palm Beach County Department of Economic Sustainability (DES). The Project will provide a storm drainage system for Limestone Creek Road north of Church Street and all of Mitchell Street. Sidewalks will be constructed along both roadways.


