I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to adopt a resolution of the Board of County Commissioners regarding the number of members of the governing board of the Palm Beach County Educational Facilities Authority (the "Authority").

Summary: The resolution confirms that the Authority is governed by a seven member board and ratifies all prior action of the Board of County Commissioners appointing seven members. Countywide (PFK)

Background and Policy Issues: The Authority was created pursuant to Chapter 243, Florida Statutes and by Resolution No. R-79-1493 adopted by the Board on October 23, 1979. The Authority was originally governed by five members appointed by the Board. Subsequent to the increase in the membership of the Board from five to seven members, the Board has appointed seven members to the Authority. This resolution confirms that the Authority is governed by a seven member governing body whose members are appointed by the Board and ratifies all prior action of the County Commission in appointing a seven member board to the Authority.

RESOLUTION NO. R-2012-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA RATIFYING THE CONSTITUENCY OF THE GOVERNING BOARD OF THE PALM BEACH COUNTY EDUCATIONAL FACILITIES AUTHORITY AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Palm Beach County Educational Facilities Authority (the "Authority") was created pursuant to Chapter 243, Florida Statutes and by Resolution No. R-79-1493 adopted by the Board of County Commissioners (the "Board") on October 23, 1979, as ratified by Resolution No. R-86-598 adopted by the Board of County Commissioners on April 22, 1986 (said resolutions being jointly referred to as the "Enabling Resolutions"); and

WHEREAS, pursuant to the Enabling Resolutions, the governing board of the Authority consists of members (the "Members") appointed by the Board; and

WHEREAS, the Enabling Resolutions provide that there shall be five Members, but subsequent to the adoption of the Enabling Resolutions the constituency of the Board was increased from five to seven members by amendment to the County Charter and the Board then increased the number of Members of the Authority from five to seven; and

WHEREAS, the Board desires to ratify its prior actions increasing the number of Members of the Authority to seven.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY THAT:

Section 1. The Authority shall be governed by a governing board consisting of seven Members appointed by the Board. All prior actions by the Board appointing a governing board of the Authority consisting of seven Members are ratified.
