I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: A) Amendment to the Amended and Restated Agreement (R2011-1435) with Palm Beach County Sports Commission, Inc. (the "PBCSC") for the provision of services under Palm Beach County's (PBC) Tourist Development Plan during the period of October 1, 2011 through September 30, 2012; deleting the requirement that the TDC Executive Director be an ex-officio member of the Sports Commission; B) adding the requirement that the TDC's Executive Director shall be notified of all meetings of the Board of Directors, and the executive committee as well as all committees and subcommittees of the Sports Commission whose functions are in any way related to the expenditure of County or Tourist Development Tax funds. The TDC's Executive Director shall be provided notice of meetings and an opportunity to be heard at the meetings. Notice of the meetings shall be provided to the TDC's Executive Director no later than five (5) days before the meeting is to occur; C) that the BCC appointees of the Sports Commission shall comply with the provisions of the Palm Beach County Code of Ethics, Sections 2-441 through 2-448 (as amended from time to time) of the County Code; and D) The Sports Commission may offer its employees a simplified employee pension plan. Contributions to such plan shall not exceed seven (7%) percent of the employees' actual salaries; and E) amending Exhibit A -FY 2012 budget in the amount of \$100,000.

Summary: This amendment to the Amended and Restated Agreement removes the reference that the TDC Executive Director serves as ex-officio member of the Sports Commission's committees and sub-committees, but requires notification of all meetings and an opportunity to be heard and revises language to the Palm Beach County Code of Ethics by adding the BCC appointees into the body of the agreement. The Sports Commission may offer its employees a simplified employee pension plan. Contributions to such plan shall not exceed seven (7%) percent of the employees' actual salaries. This provision reduces the current employer contribution from 10% to 7% in conformity with the other TDC agencies and amends Exhibit A in the amount of \$100,000 for sports related grants. (TDC) Countywide (DW)

Background and Justification: The amendment to the Amended and Restated Agreement provides that BCC appointees shall comply with the provisions of the Palm Beach County Code of Ethics, sections 2-441 through 2-448 (as amended from time to time) of the County Code, and states that the TDC Executive Director shall be notified of all meetings and have an opportunity to be heard at all meetings. The Sports Commission may offer its employees a simplified employee pension plan. Contributions to such plan shall not exceed seven (7%) percent of the employees' actual salaries. Due to the increase in bed tax collections in FY 2011 the Sports Commission requested use of reserves to secure additional sporting events. The TDC Finance Committee and TDC Board approved the use of reserves to fund additional sporting events on March 8, 2012.

FIRST AMENDMENT TO AMENDED AND RESTATED AGREEMENT

THIS FIRST AMENDMENT to the AMENDED AND RESTATED AGREEMENT (R2011-1435) is made as of this _____ day of _____, 2012, by and between Palm Beach County, a Political Subdivision of the State of Florida, by and through its Board of Commissioners, (hereinafter referred to as "COUNTY"), and PALM BEACH COUNTY SPORTS COMMISSION, INC., a Florida not-for-profit corporation, whose Federal I.D. is 59-1862336 (hereinafter referred to as "PBCSC").

WITNESSETH:

WHEREAS, the COUNTY and PBCSC entered into that certain Amended and Restated Agreement dated September 13, 2011; and

WHEREAS, the parties desire to make certain revisions to that Amended and Restated Agreement as set forth in this First Amendment.

NOW THEREFORE, in consideration of the mutual promises contained herein, the COUNTY and the PBCSC agree as follows:

1. Paragraph 2 of the Amended and Restated Agreement is hereby amended as follows:

Qualifications and Performance of Contractors

Any personnel or entities with which PBCSC enters into contracts for services pursuant to this Agreement shall be specifically experienced in, and qualified for, the provision of such services. As contract administrator, PBCSC shall develop evaluation criteria, monitor and evaluate the performance of all such contractors. PBCSC shall provide to the Executive Director of the TDC a semi-annual report summarizing the results of such monitoring and evaluation, and shall take reasonable measures to assure the continued satisfactory performance of all such contractors. Should PBCSC, after taking such reasonable measures, determine that such contractor who has contracted with PBCSC has failed to perform in accordance with its contract, PBCSC shall terminate such contract. PBCSC shall continuously keep the Executive Director of the TDC fully informed as to all activities of PBCSC so as to enable the Executive Director to effectively provide overall direction and guidance for the COUNTY'S Tourist Development Plan as established by the TDC and the County. The TDC's Executive Director shall be notified of all meetings of the Board of Directors, and the executive committee as well as all committees and subcommittees of the PBCSC whose functions are in any way related to the expenditure of COUNTY or Tourist Development Tax funds. The TDC's Executive Director shall be provided an opportunity to be heard at said meetings, as well as minutes of the meetings.

2. Paragraph 6, Policies and Procedures, A. Personnel, of the Amended and Restated Agreement is amended to add subsection (iv) as follows:

(iv) PBCSC may offer its employees a simplified employee pension plan. Contributions to such plan shall not exceed seven (7%) percent of the employees'

actual salaries. PBCSC shall incorporate the provisions of such plan into the policies and procedures of the PBCSC, and shall notify COUNTY of any proposed revision to the plan prior to implementation.

3. The first sentence of Paragraph 28 of the Amended and Restated Agreement is hereby amended as follows:

The BCC appointees of the Sports Commission shall comply with the provisions of the Palm Beach County Code of Ethics, Sections 2-441 through 2-448 (as amended from time to time) of the County Code.

4. Exhibit A, the Fiscal Year 2012 budget is hereby amended and attached hereto.

5. All other provisions of said Amended and Restated Agreement are hereby confirmed and, except as provided herein, are not otherwise altered or amended and shall remain in full force and effect.

FIRST AMENDMENT TO AMENDED AND RESTATED AGREEMENT

THIS FIRST AMENDMENT to the AMENDED AND RESTATED AGREEMENT (R2011-1435) is made as of this ______ day of ______, 2012, by and between Palm Beach County, a Political Subdivision of the State of Florida, by and through its Board of Commissioners, (hereinafter referred to as "COUNTY"), and PALM BEACH COUNTY SPORTS COMMISSION, INC., a Florida not-for-profit corporation, whose Federal I.D. is 59-1862336 (hereinafter referred to as "PBCSC").

WITNESSETH:

WHEREAS, the COUNTY and PBCSC entered into that certain Amended and Restated Agreement dated September 13, 2011; and

WHEREAS, the parties desire to make certain revisions to that Amended and Restated Agreement as set forth in this First Amendment.

NOW THEREFORE, in consideration of the mutual promises contained herein, the COUNTY and the PBCSC agree as follows:

1. Paragraph 2 of the Amended and Restated Agreement is hereby amended as follows:

Qualifications and Performance of Contractors

Any personnel or entities with which PBCSC enters into contracts for services pursuant to this Agreement shall be specifically experienced in, and qualified for, the provision of such services. As contract administrator, PBCSC shall develop evaluation criteria, monitor and evaluate the performance of all such contractors. PBCSC shall provide to the Executive Director of the TDC a semi-annual report summarizing the results of such monitoring and evaluation, and shall take reasonable measures to assure the continued satisfactory performance of all such contractors. Should PBCSC, after taking such reasonable measures, determine that such contractor who has contracted with PBCSC has failed to perform in accordance with its contract, PBCSC shall terminate such contract. PBCSC shall continuously keep the Executive Director of the TDC fully informed as to all activities of PBCSC so as to enable the Executive Director to effectively provide overall direction and guidance for the COUNTY'S Tourist Development Plan as established by the TDC and the County. The TDC's Executive Director shall be notified of all meetings of the Board of Directors, and the executive committee as well as all committees and subcommittees of the PBCSC whose functions are in any way related to the expenditure of COUNTY or Tourist Development Tax funds. The TDC's Executive Director shall be provided an opportunity to be heard at said meetings, as well as minutes of the meetings.

2. Paragraph 6, Policies and Procedures, A. Personnel, of the Amended and Restated Agreement is amended to add subsection (iv) as follows:

(iv) PBCSC may offer its employees a simplified employee pension plan. Contributions to such plan shall not exceed seven (7%) percent of the employees' actual salaries. PBCSC shall incorporate the provisions of such plan into the policies and procedures of the PBCSC, and shall notify COUNTY of any proposed revision to the plan prior to implementation.

3. The first sentence of Paragraph 28 of the Amended and Restated Agreement is hereby amended as follows:

The BCC appointees of the Sports Commission shall comply with the provisions of the Palm Beach County Code of Ethics, Sections 2-441 through 2-448 (as amended from time to time) of the County Code.

4. Exhibit A, the Fiscal Year 2012 budget is hereby amended and attached hereto.

5. All other provisions of said Amended and Restated Agreement are hereby confirmed and, except as provided herein, are not otherwise altered or amended and shall remain in full force and effect.

IN WITNESS WHEREOF, the parties hereto have executed this First Amendment on behalf of the COUNTY and the SPORTS COMMISSION has hereunto set its hand the day and year above written.
