I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: letters from the City of Boca Raton, the Boca Raton Community Redevelopment Agency (CRA) and the Centre for the Arts at Mizner Park Inc., now d.b.a. the Schmidt Family Centre for the Arts (Centre), advising of the transfer of ownership and management of the Mizner Park Amphitheater to the City of Boca Raton and acceptance of the obligations of Agreement R2001-0779 by the City of Boca Raton.

Summary: The Mizner Park Amphitheater (project) was partially funded in the amount of \$2,000,000 from the 1999 \$25 Million Recreation and Cultural Facilities Bond. A tri-party funding agreement (R2001-0779) with the CRA and the Centre provided for construction and long-term management of the project. The ownership and management of the amphitheater has now been transferred from the CRA and the Centre to the City of Boca Raton. The City has accepted the ownership and management obligations for the project in accordance with the terms of the Agreement. Transfer of ownership and management of the project to a governmental entity is permissible under Section 4.05 of the Agreement. District 4 (PK)

Background and Justification: The Mizner Park Amphitheater project was constructed and is operating in accordance with the terms of the referenced Interlocal Agreement. The City of Boca Raton, the CRA and the Centre have provided notification of transfer of ownership and management of the project in accordance with the terms of the Agreement.

On February 13, 2012, the Boca Raton Community Redevelopment Agency transferred ownership of the Mizner Park Amphitheater to the City of Boca Raton. This transfer is subject to the Interlocal Agreement between Palm Beach County, the Boca Raton Community Redevelopment Agency, and Centre for the Arts at Mizner Park, Inc. for funding of the Centre for the Arts at Mizner Park – Phase II, dated May 15, 2001.

Dear Mr. Ahnell:

The Centre for the Arts at Mizner Park, Inc., formerly known as Concert Hall at Mizner Park, Inc., and now d.b.a. the Schmidt Family Centre for the Arts (the "SFCFA") has been asked to provide a letter of explanation with regard to the termination of that certain lease between the Boca Raton Community Redevelopment Agency ("Boca CRA") and the SFCFA entitled Centre for the Arts Lease and dated December 19, 1997 ("CRA/CFA Lease").

The CRA/CFA Lease provided for the use of the "cultural parcel" at the north end of Mizner Park comprised of three elements: a concert hall, a museum of art and a state of the art amphitheater. During the effective period of the CRA/CFA Lease, the Boca Raton Museum of Art and the Mizner Park Amphitheater were constructed and successfully operated. The construction of the Mizner Park Amphitheater was funded in part by a \$2 million cultural arts grant from Palm Beach County.

The SFCFA's business model was based on the use of charitable gifts, memberships, corporate sponsorships, government grants and commercial rentals to support the discounted use of the Amphitheater by non-profit organizations. The Amphitheater opened in November of 2002 and was a substantial success with more literally hundreds of events and the establishment of the Festival of the Arts BOCA. Beginning in late 2007, the economic slowdown and an increasingly steep decline in charitable giving and corporate support, declining support from public agencies, the demise of Fantasma Productions Inc. (the SFCFA's commercial production partner) and structural changes in the commercial concert industry undermined the SFCFA's ability to fund the cost of maintenance and operation of the Amphitheater. After extensive discussions with the Boca CRA and the City of Boca Raton with regard to CRA/City funding for non-profit operation of the Amphitheater, the SFCFA and the CRA/City agreed to terminate the CRA/CFA Lease and for the CRA to assume operational response for the Amphitheater.
