I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Work Authorization No. 16 to the contract for Pipeline Continuing Construction Contract with AKA Services, Inc. (R2010-1422) for the construction of the Morikami Park 16" Reclaimed Water Main Extension Project in the amount of \$638,643.37.

Summary: On September 14, 2010, the Palm Beach County Board of County Commissioners approved the Water Utilities Department Pipeline Continuing Construction Contract with AKA Services, Inc. (R2010-1422). This Work Authorization No.16 provides for the construction of a 16" Reclaimed Water Main to provide reclaimed water service for irrigation purposes to the Morikami Museum & Japanese Gardens (Morikami Park), the Delray Beach Civic Center & Park Facilities, and nearby residential communities. Staff is currently in discussions with Kings Point Community. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance (R2002-0064) is 15% overall. The contract with AKA Services, Inc. provides for SBE participation of 15% overall. This Authorization includes 15.47% overall participation. The cumulative SBE participation, including this Authorization, is 14.42% overall. AKA Services, Inc. is a local Palm Beach County company. (WUD Project No. 11-027) <u>District 5</u> (MJ)

Background and Justification: The Palm Beach County Water Utilities Department is dedicated to promoting economically and technically feasible technologies for water conservation. One component of this effort is irrigation utilizing reclaimed water from the Southern Region Water Reclamation Facility. Reclaimed water systems offer significant advantages to consumers and the environment by reducing the demand on potable water resources and by offering consumers an alternative to reducing irrigation frequency during times of drought. The reclaimed water pipeline will be installed (approximately 6,370 feet) through Morikami Park along the north side of Morikami Park Road and connect south to an existing pump storage facility along the Park's south access road. The existing storage tank is out of service and is being converted to a reclaimed water storage tank. Constructing this pipeline and utilizing the storage tank at Morikami Park will allow the County to add additional reclaimed customers in that portion of the service area.



SCOPE OF WORK FOR

Morikami Park 16" Reclaimed Water Main Extension INTRODUCTION

Palm Beach County (County) entered into a Contract for Construction Services date September 14, 2010 (Resolution/Document R2010-1422), by and between Palm Beach County and AKA Services, Inc., for the Construction Services of this Authorization.

This Contract for Construction Services encompasses providing services related to installation of the potable water mains and services and force mains to The North County General Aviation Airport.

SCOPE OF SERVICES

The Contractor shall provide and install 3,810 If of 16" PVC reclaimed water main, 1,940 If of 16" DIP reclaimed water main, 272 If of 8" DIP reclaimed water main, 20 If of 6" DIP reclaimed, 210 If of 4" DIP reclaimed water main, and 4 connections to existing reclaimed water main. All reclaimed water mains shall be constructed in accordance with Palm Beach County Water Utilities Department Minimum Engineering and Construction Standards, as indicated in the construction plans and contract documents.


