I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Reopening twelve (12) vacant treatment beds at Highridge Family Center (HRFC) in order to reduce the waiting list which, at times, has reached as high as 100 youths. This would be accomplished at no additional cost (other than minor food cost) through the re-assignment, restructuring, and re-training of staff from the Youth Service Bureau.

Summary: Since the closure in 2008 of the two (2) dormitories (24 beds) at the Highridge Family Center for budgetary and low census reasons, there has been a consistent waiting list. At one point, there were one-hundred (100) youths on the waitlist with seventy five (75) of them male and twenty five (25) female. While there are seasonal fluctuations in requesting these services, a consistent waitlist is not uncommon. The HRFC provides families with high quality comprehensive family services counseling to prevent "at risk" children from entering the Juvenile Justice System. At the one year follow up, 91.7% of the youths that completed our program had not been arrested as evidenced by preliminary study results of six years of program participants (2003-2009). Furthermore, at the end of treatment, parents reported a decrease in aggression, behavior conduct problems, and hyperactivity; and, an increase in social skills, leadership, and communication. Parents have also reported children completing the treatment program have significantly improved their school grades during the 90 day program. By reassigning and restructuring the Division of Youth Affairs, staff will be able to support the additional males that will be placed in the 12 beds. Countywide (PGE)

Background and Policy Issues: As a result of the ever increasing need for our services, a twelve (12) bed dormitory would be reopened and four (4) current staff reassigned to provide the direct clinical services to the new residents. The reassigned staff would include three (3) Family Counselors and one (1) Family Therapist from the Youth Affairs Youth Service Bureau (YSB). Currently, the Family Counselors are responsible for:

- 1. Providing psycho-educational groups in schools,
- 2. Conducting admission interviews and assessments, and
- 3. Filling in with clerical and reception responsibilities.

Reassigning these staff to HRFC would utilize them in a more direct clinical service to our clientele. They would be responsible for the day-to-day, hour-by-hour management of the additional 12 residents we could admit to the program. They would continue to provide psychoeducational counseling groups as well as cover recreational and daily living activities. In short, they would be offering far more direct service than they are in their current role at YSB. This shift would require remaining YSB staff to assume these responsibilities. Currently, the YSB family therapist is responsible for:

- 1. Providing Family Therapy to an assigned caseload,
- 2. Providing Therapy and Psycho-educational groups to schools and special programs,
- 3. Providing Individual Therapy on an as-needed basis, and

Re-assigning these staff members to the HRFC would not significantly change their existing responsibilities other than to work with children in a different environmental setting.
