#### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to adopt: A Resolution to support the conservation of native wildflowers.

**SUMMARY**: Grants for the planting of wildflowers are available from the Florida Wildflower Foundation to counties, municipalities and other entities through the sale of State of Florida Wildflower license plates. For applicants to be eligible for the La Florida "Land of Flowers" Community Grant Program, it is necessary for counties or municipalities to have adopted resolutions committing to support the conservation of Florida's native wildflowers.

## Countywide (MRE)

Background and Justification: The Florida Wildflower Foundation (Foundation) is a 501(c)3 nonprofit organization whose mission is to enrich lives with Florida's native wildflowers. With donations made with the sale of each State Wildflower license plate, the Foundation funds research, education and planting projects statewide. The Community Grant Program is one example of this Foundation's programs. Adoption of this Resolution will enable entities to apply to the Foundation for grants that will increase the visibility of native wildflowers.
