I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: The Weizer family's request to honor Bill Weizer by dedicating the Island Way bridge, north of Indiantown Road, to him.

SUMMARY: Approval of this motion will honor Bill Weizer for the many years he worked to make Island Way a reality. Dedication signs will be installed on the Island Way bridge by the Road and Bridge Division in accordance with the intent of Countywide PPM# CW-O-044 honoring individuals. The District 1 Commissioner supports this request. The Weizer family has agreed to fund the approximate cost of \$200 for the dedication signs. Mr. Weizer originally owned property surrounding Island Way that was sold 12 years ago, and he spent many years working to make the access road a reality until he passed away in 1998.
