I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Change Order No. 15 to the contract with Catalfumo Construction, Ltd. (R2007-1217) decreasing the Guaranteed Maximum Price (GMP) for the Government Center Chiller project in the amount of \$164,206.79.

Summary: On June 8, 2010, the Board approved Amendment No. 7 to the contract with Catalfumo Construction, Ltd. in the amount of \$4,209,613 for construction of a new chiller plant for the Government Center and Historic Courthouse. There is \$164,206.79 remaining as a result of buyout savings, unused allowances, unused owner contingency and reconciliation of sales tax recovery purchase orders. The amendment was funded from Bonds and Ad Valorem and remaining funds will be returned to the Public Building Improvement Fund. The Small Business Enterprise (SBE) goal for this contract is 15% and the final SBE participation is 45%. (Capital Improvements Division) Countywide/District 7 (JM)

Background and Justification: On June 8, 2010, the Board approved Amendment No. 7 with Catalfumo Construction, Ltd. for construction management services to construct a new chiller plant to service the Government Center and Historic Courthouse. After reconciliation of the final construction costs, a credit of \$164,206.79 is being returned to the County.


