I. EXECUTIVE BRIEF

MOTION AND TITLE: Staff recommends motion to approve: (A) a Budget Amendment of \$175,501 in the Criminal Justice Grants Fund to decrease budget for the Justice Assistance Grant (JAG) Program Local Solicitation Grant award from the Department of Justice (DOJ); and (B) a Budget Amendment of \$175,501 in the JAG Program Local Solicitation Grant Fund to establish budget for the JAG Program Grant.

SUMMARY: Palm Beach County, through the Criminal Justice Commission (CJC), was successful in receiving a grant award of \$175,501 from the DOJ to allow for the continuation of the Public Defender Re-entry and Palm Beach County Adult Drug Court Programs. For accounting reasons it is more efficient to separate JAG Program Local Solicitation Grants and keep them in their own fund. These offsetting budget amendments will allow for the grant funds to be moved from the existing fund to the new fund. <u>Countywide</u> (PGE).

BACKGROUND: The JAG Program replaces the Byrne Grant formula and the Local Law Enforcement Block Grant with a single funding source. The purpose of the JAG Program is to provide local units of government with funds to underwrite projects to reduce crime and improve public safety. CJC staff provides program oversight and grant administration. On April 23, 2012, the CJC members approved the recommendation made by the CJC Finance Committee for the FY2012 JAG Funds. The CJC members voted to recommend submittal of the two grant program proposals. JAG funds may be expended over a 48-month period to use within general federally mandated purpose areas.

This is the sixteenth (16th) year in which the Bureau of Justice Assistance, US Department of Justice, is able to provide JAG/LLEBG funds through Congressional appropriations.

On June 19, 2012 the BCC approved the submittal of the grant application (R2012-0919) and delegated signature authority to the County Administrator. Subsequently on September 11, 2012 the BCC approved the receipt and filing of the grant award (R2012-1294).
