## II. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** the creation of one (1) full-time position within the Department of Economic Sustainability, which will be grant funded.

The requested additional staff position is necessary to ensure compliance with all Federal and State requirements.
