("Attorney"), to provide bond counsel and related legal services for the estimated \$10 Million financing of Capital Improvement Revenue Bond, Series 2012A (Voice Over Internet Protocol System) (the "Bonds").							
<b>Summary</b> : The Attorney was selected as bond counsel for the above financing by the County Financing Committee at an August 23, 2012 meeting.
